




Transconductance






Transfer Characteristics




On-Resistance vs. Drain Current







Threshold Voltage




Drain Source Breakdown vs. Junction Temperature





Normalized Thermal Transient Impedance, Junction-to-Foot

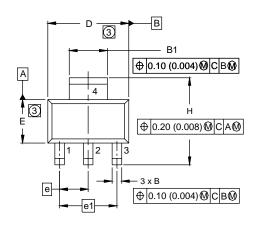

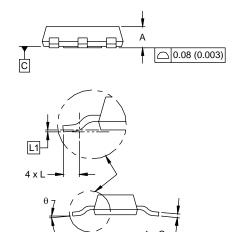
