










Source-Drain Diode Forward Voltage




 $\mathsf{R}_{\mathsf{DS}(\mathsf{on})}$ - Drain-to-Source On-Resistance (Ω)



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient





Safe Operating Area, Junction-to-Ambient






T_C - Case Temperature (°C) **Current Derating***



Power, Junction-to-Case






Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot
