


**On-Resistance vs. Drain Current** 




**Gate Charge**



**On-Resistance vs. Junction Temperature** 






Source-Drain Diode Forward Voltage







On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power (Junction-to-Ambient)
