









Source-Drain Diode Forward Voltage

T_J - Temperature (°C)

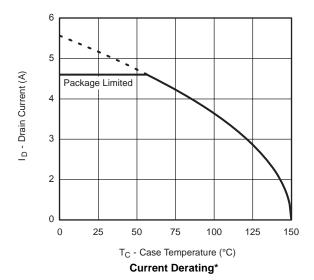





Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot
