






Source-Drain Diode Forward Voltage



Single Pulse Power








Current Derating*






Power Derating, Junction-to-Ambient



THERMAL RATINGS ($T_A = 25$ °C, unless otherwise noted)










Normalized Thermal Transient Impedance, Junction-to-Foot


