



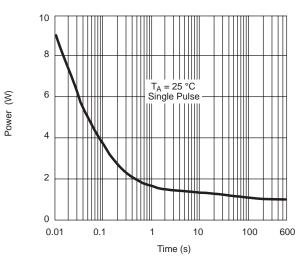


#### Source-Drain Diode Forward Voltage



Single Pulse Power










T<sub>C</sub> - Case Temperature (°C)






Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot
