







#### Source-Drain Diode Forward Voltage










#### **Threshold Voltage Variance Over Temperature**


Single Pulse Power, Junction-to-Ambient


#### Normalized Thermal Transient Impedance, Junction-to-Foot

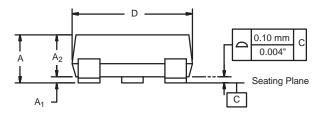

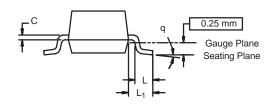
