






#### Source-Drain Diode Forward Voltage



Single Pulse Power










T<sub>C</sub> - Case Temperature (°C)

#### Current Derating\*








T<sub>A</sub> - Ambient Temperature (°C) **Power Derating, Junction-to-Ambient** 



Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot
