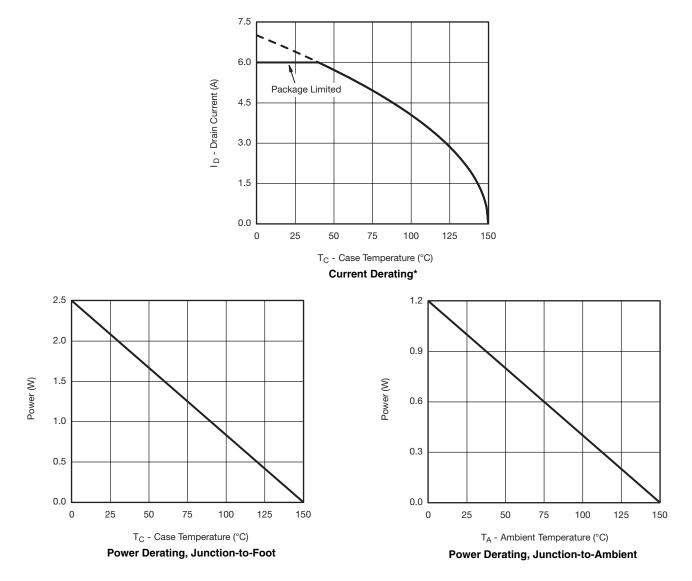








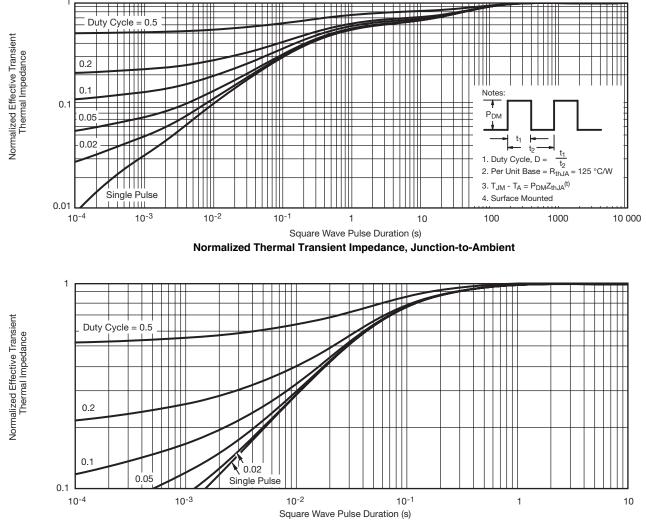
#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

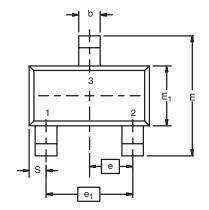
## TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

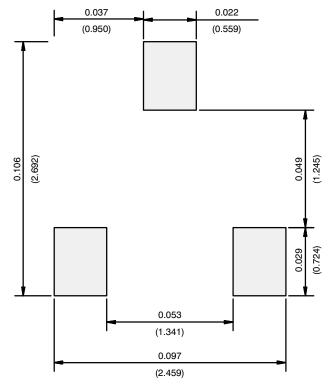
