








#### Source-Drain Diode Forward Voltage

Single Pulse Power



Safe Operating Area, Junction-to-Ambient






#### Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot
