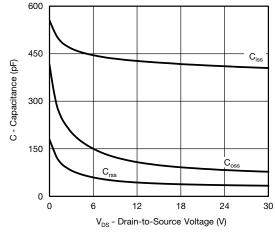


On-Resistance vs. Drain Current and Gate Voltage






Transfer Characteristics








Normalized Thermal Transient Impedance, Junction-to-Ambient





