



## TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted











#### Source-Drain Diode Forward Voltage




On-Resistance vs. Gate-Source Voltage



### $\label{eq:TJ-Junction} T_{J} \text{ - Junction Temperature (°C)}$ Threshold Voltage Variance Over Temperature






Normalized Thermal Transient Impedance, Junction-to-Ambient

#### Normalized Thermal Transient Impedance, Junction-to-Foot




