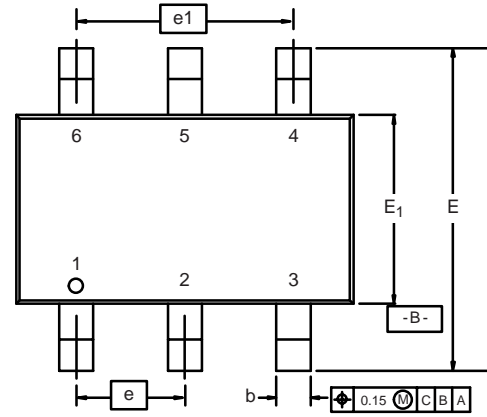

5-LEAD TSOP

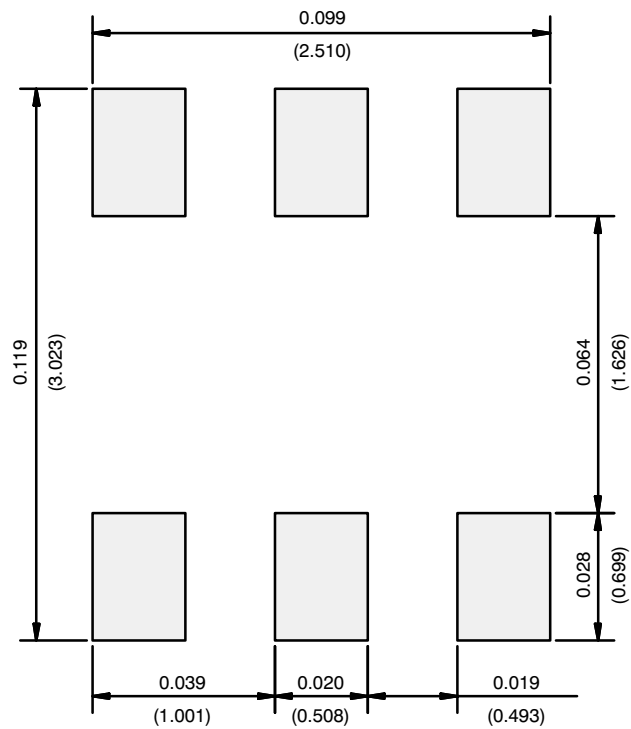
