








On-Resistance vs. Drain Current










Gate Current vs. Gate-Source Voltage







On-Resistance vs. Junction Temperature

On-Resistance vs. Gate-Source Voltage




Drain-Source Breakdown vs. Junction Temperature






Normalized thermal Transient Impedance, Junction-to-Ambient
