


**On-Resistance vs. Drain Current and Gate Voltage** 

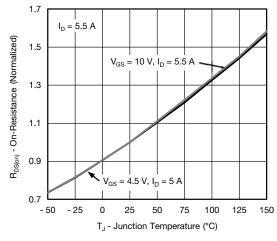




**Transfer Characteristics** 








**On-Resistance vs. Junction Temperature**


Normalized Thermal Transient Impedance, Junction-to-Ambient







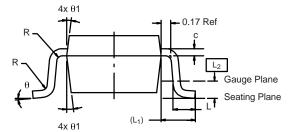


5-LEAD TSOP






