





Gate Charge

On-Resistance vs. Junction Temperature









Source-Drain Diode Forward Voltage








Threshold Voltage





Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot


