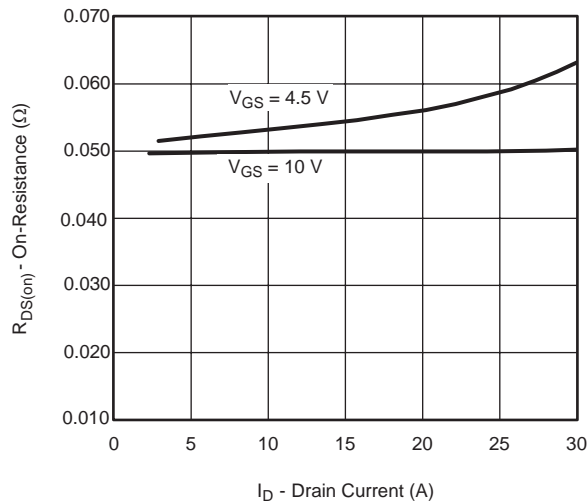

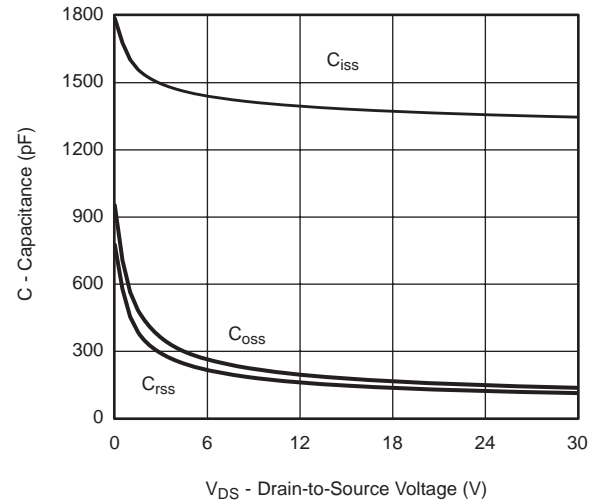

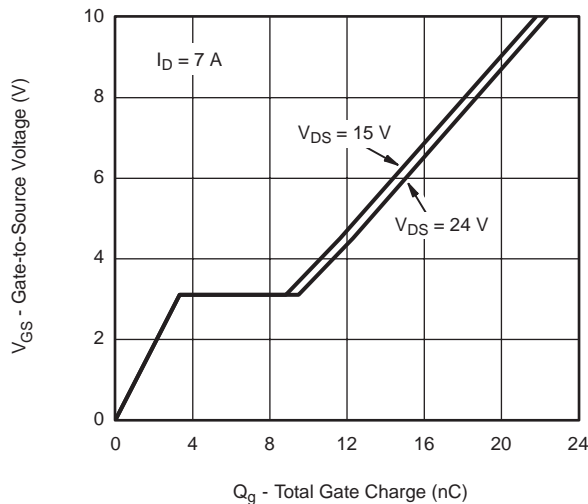
Transfer Characteristics

Capacitance

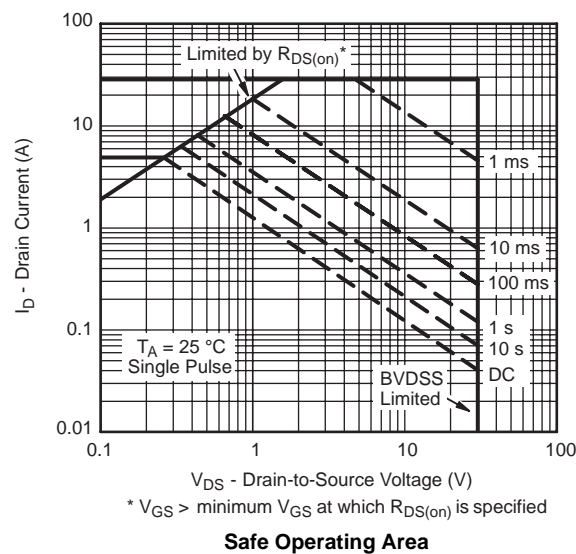
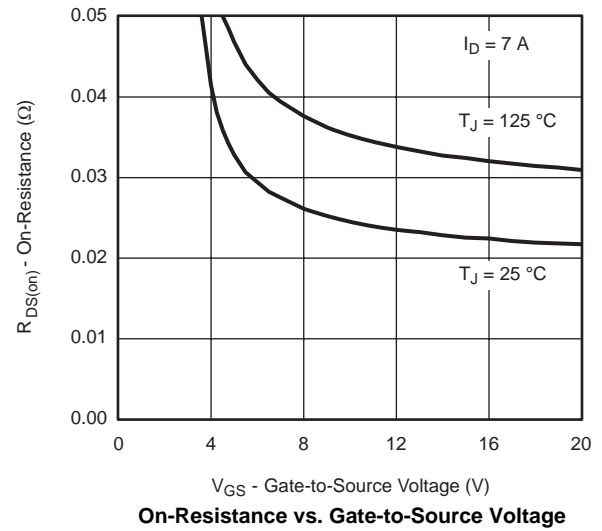
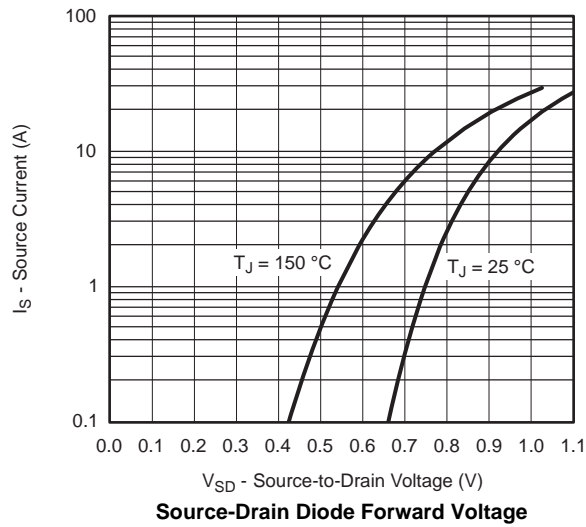


Gate Charge

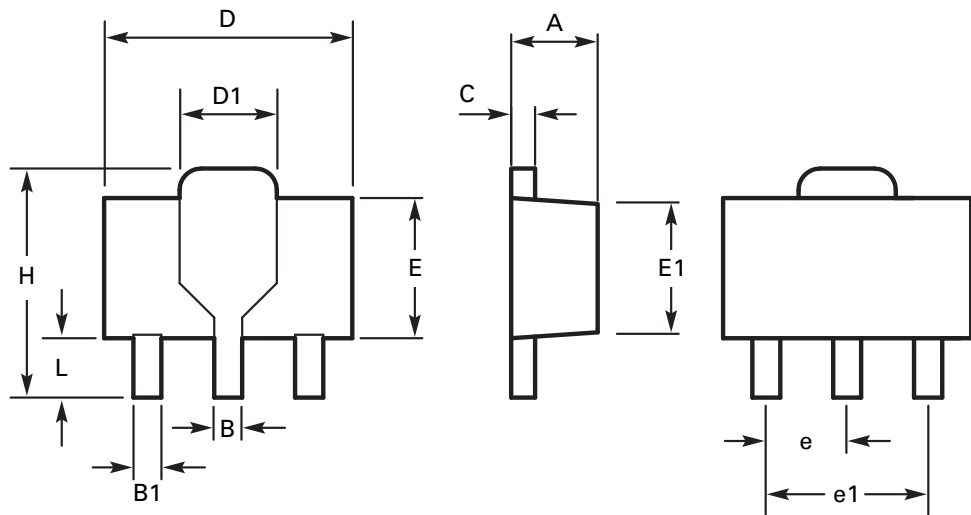
