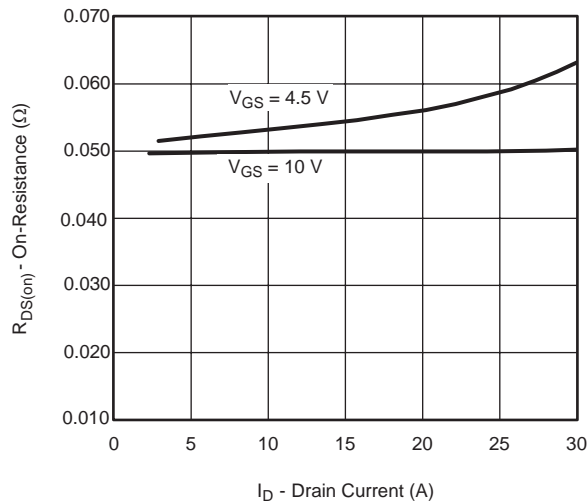

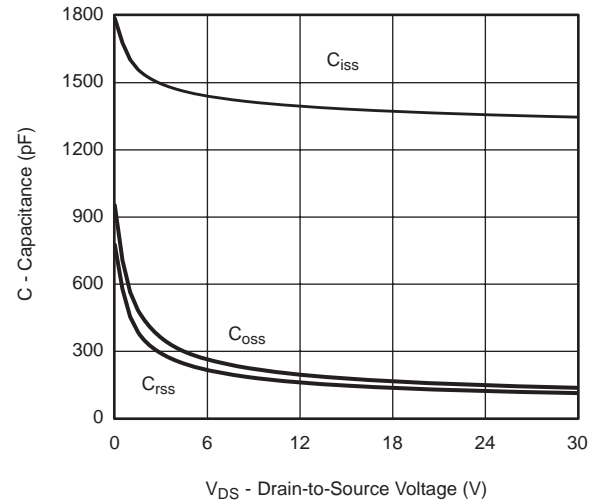

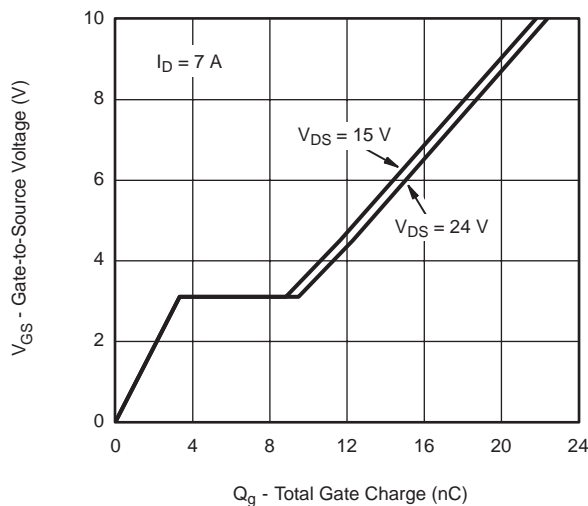

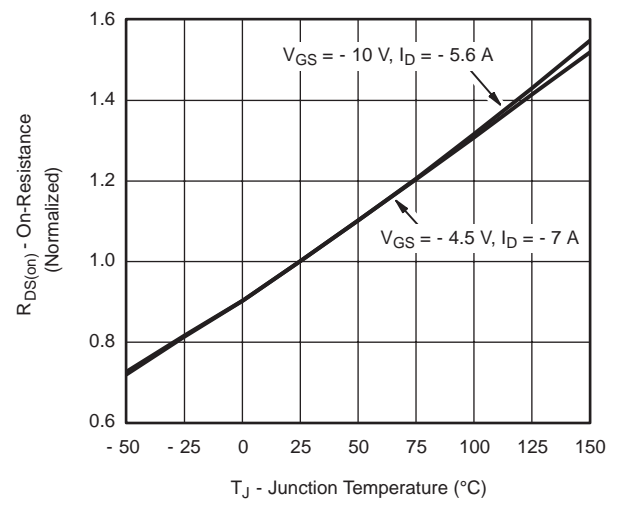
On-Resistance vs. Drain Current

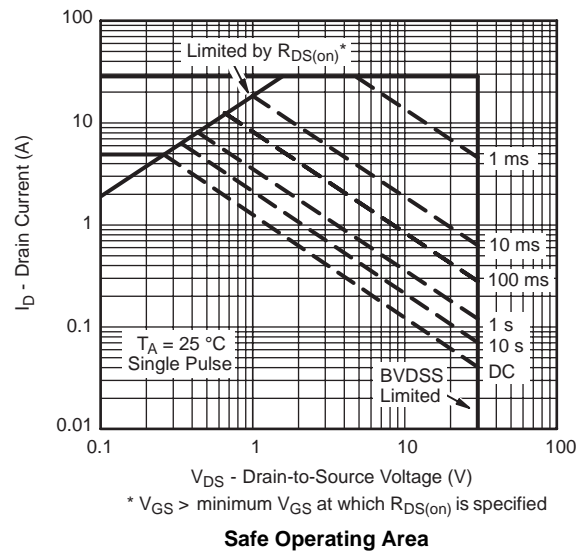
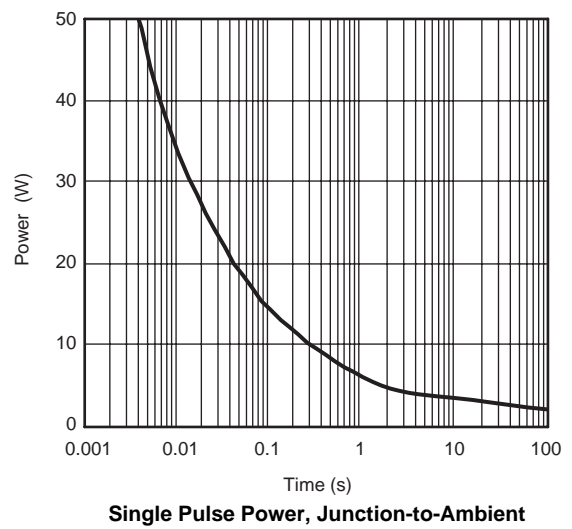
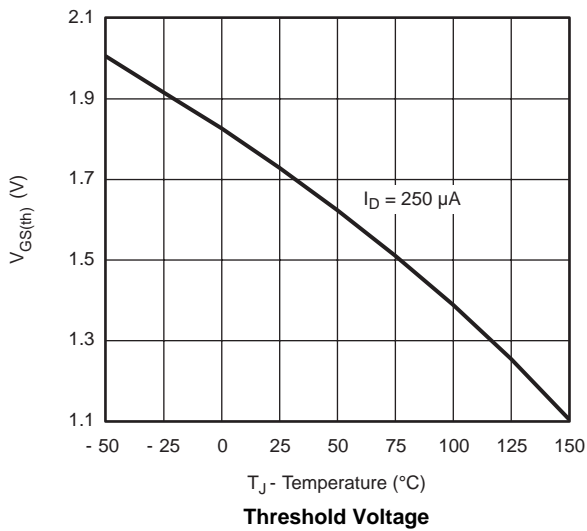
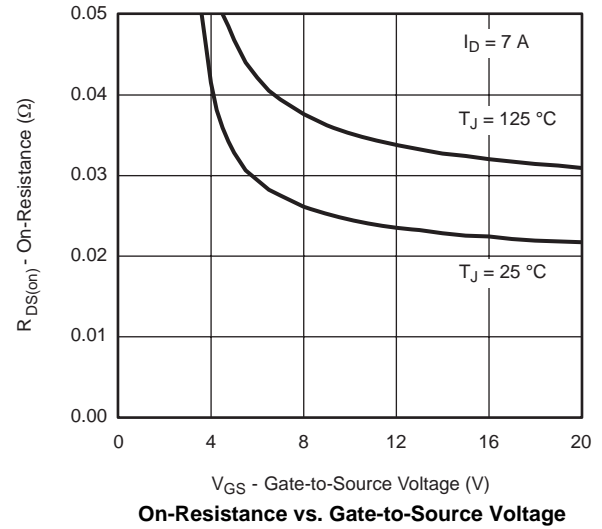
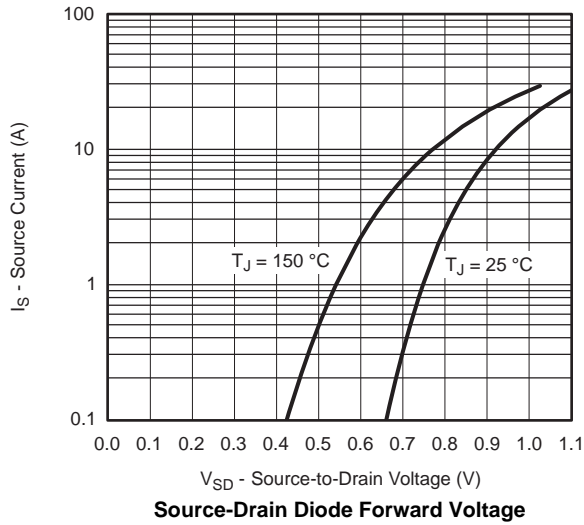


Gate Charge

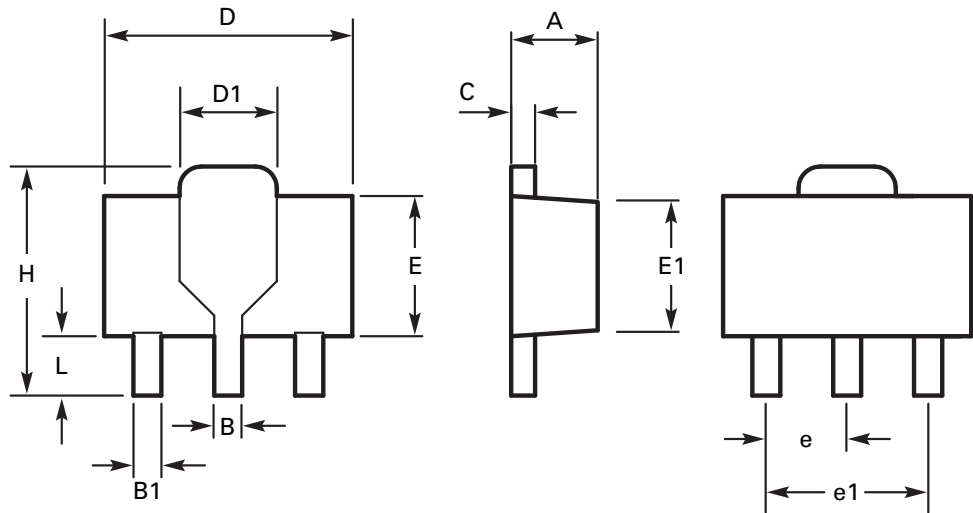
