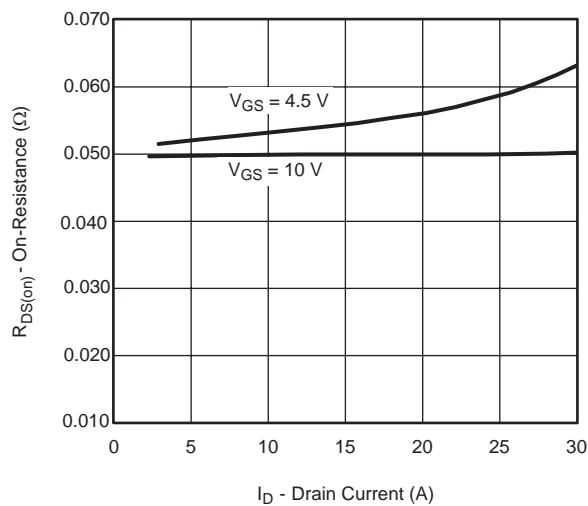

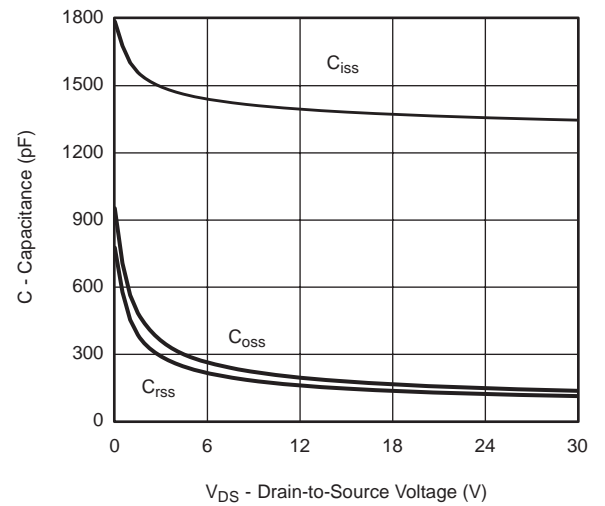
**Output Characteristics**



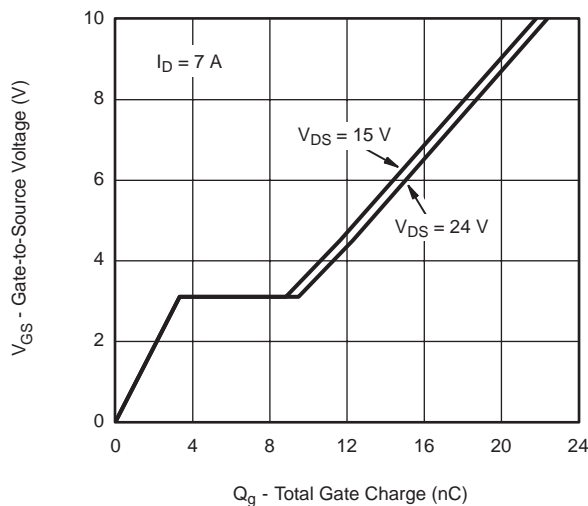
**Transfer Characteristics**

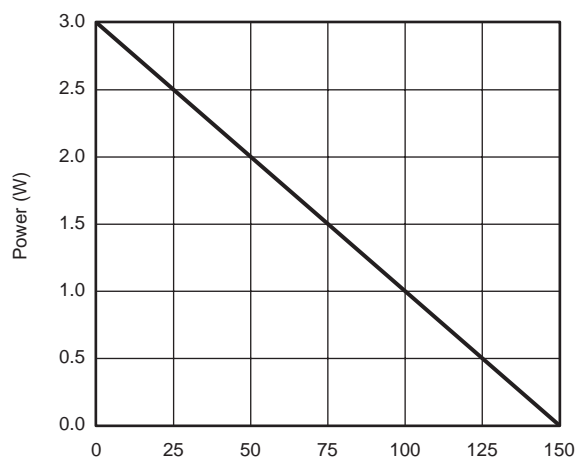
**On-Resistance vs. Junction Temperature**
