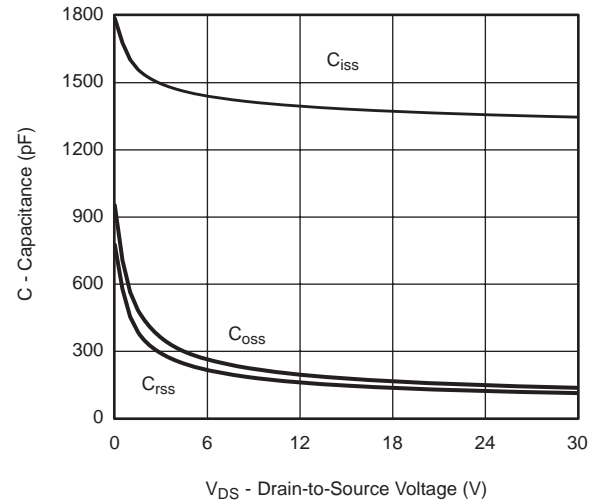

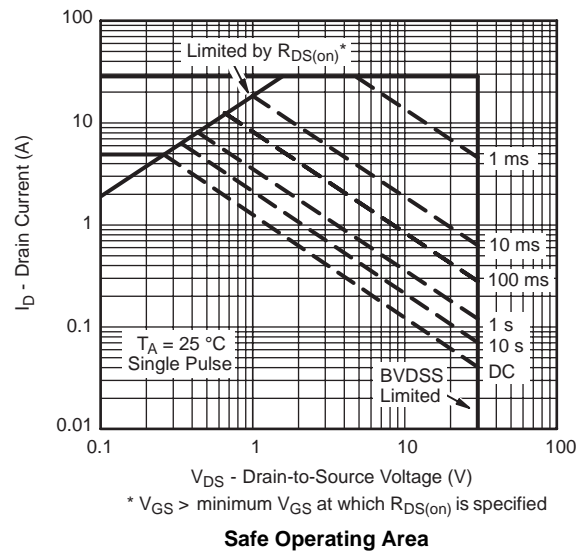
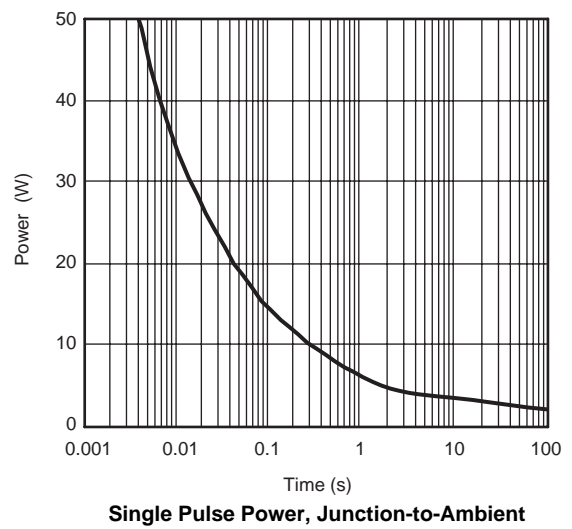
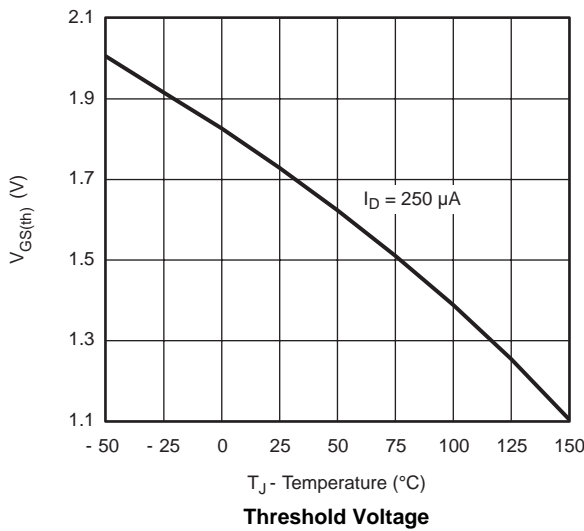
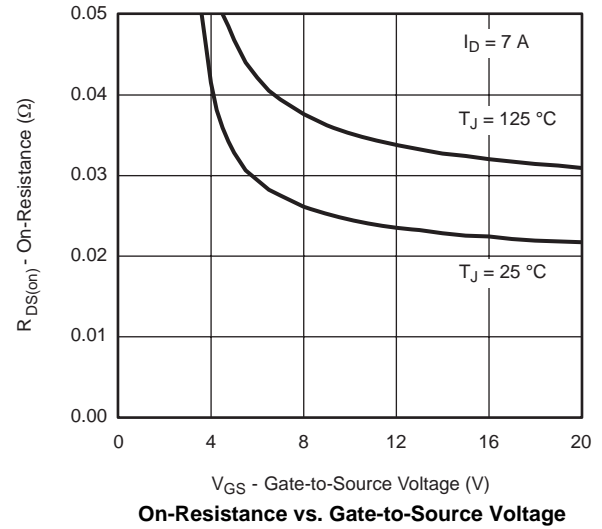
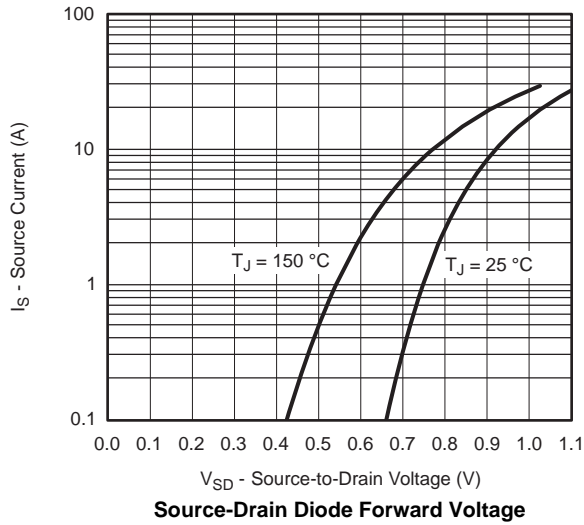


Gate Charge

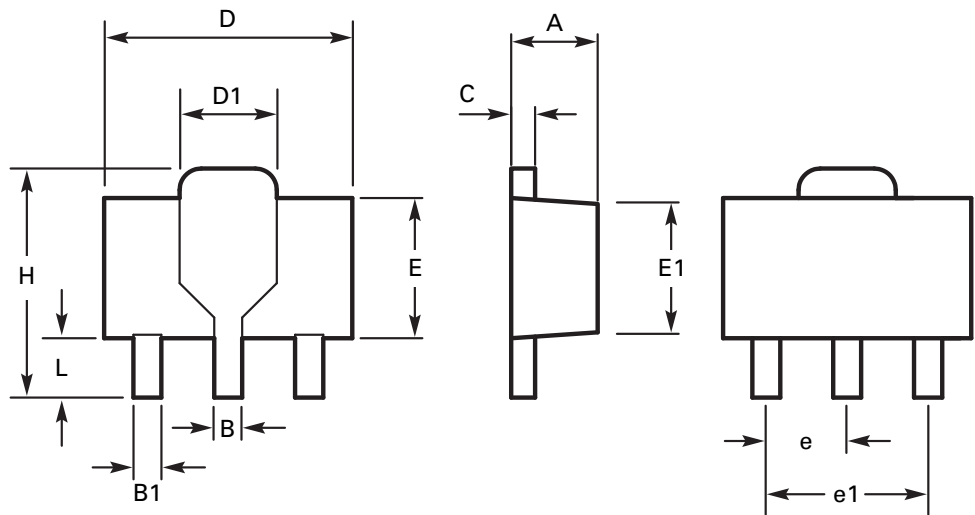
