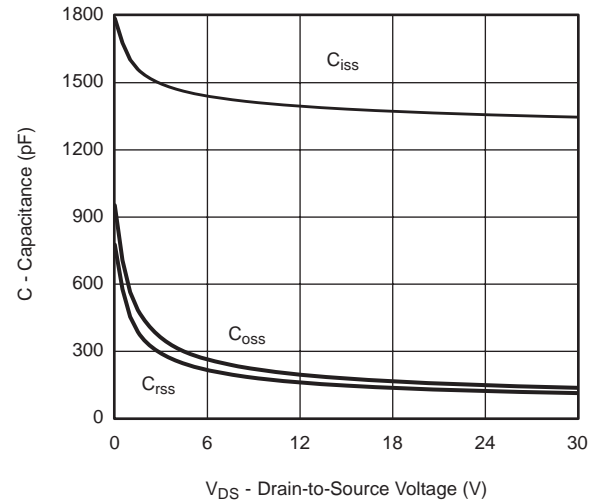

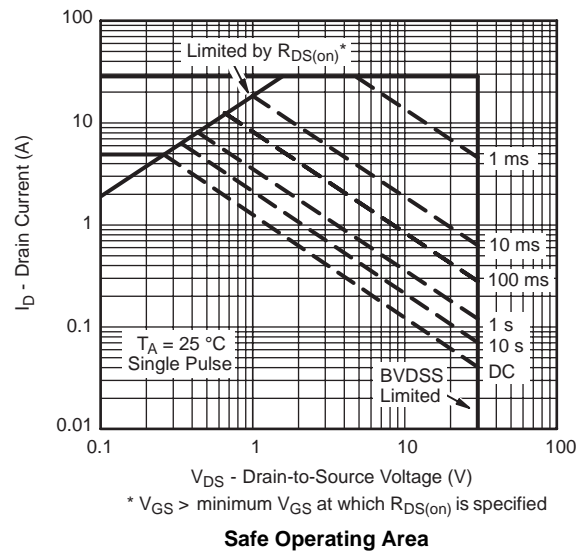
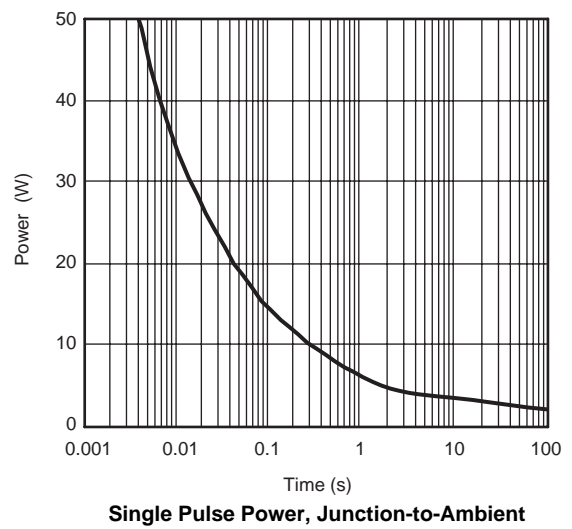
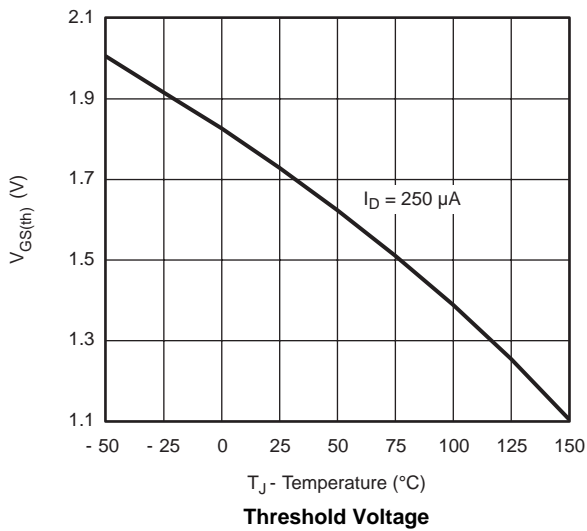
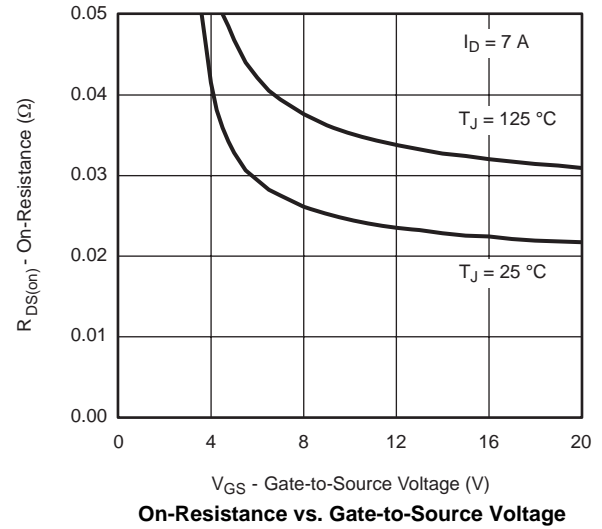
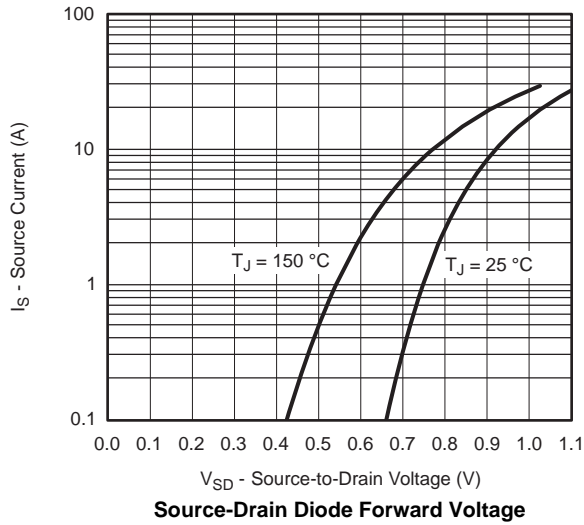


**Gate Charge**
