


#### Source-Drain Diode Forward Voltage




Single Pulse Power, Junction-to-Ambient










Current Derating\*



Power, Junction-to-Foot




Power Derating, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Ambient
