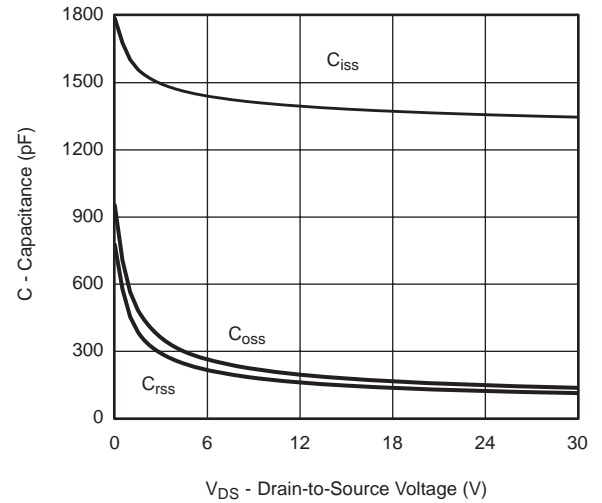

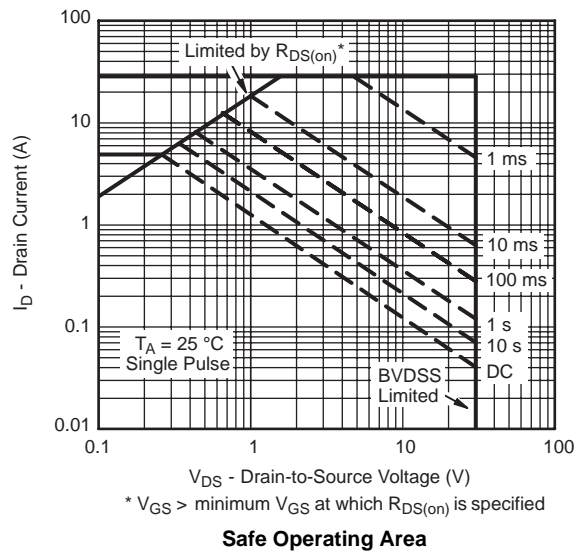
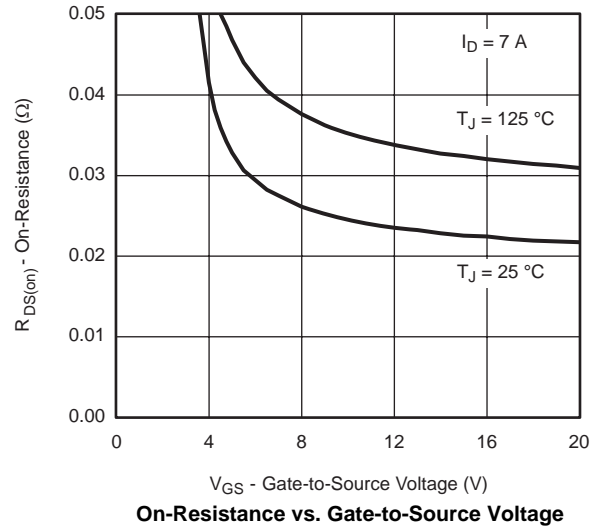
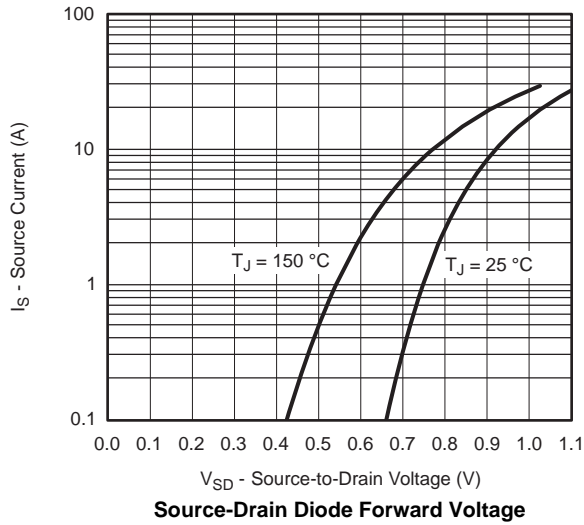


Gate Charge

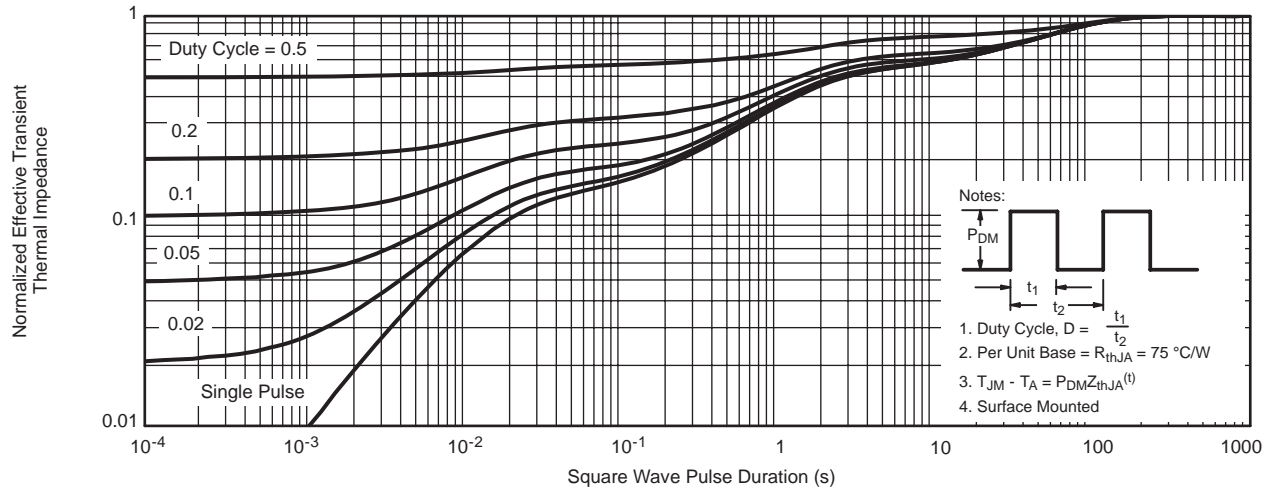

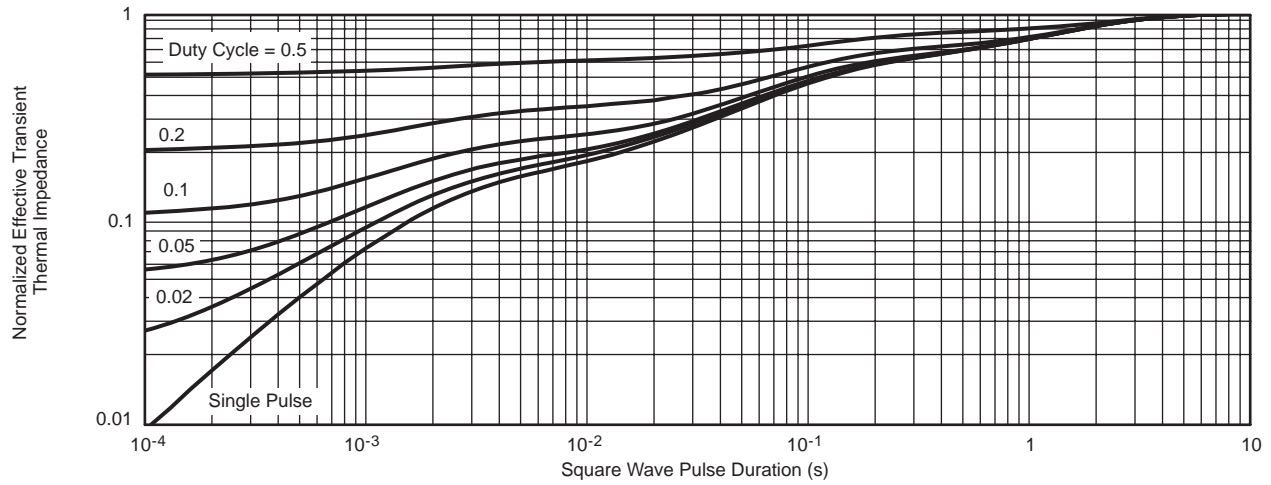
