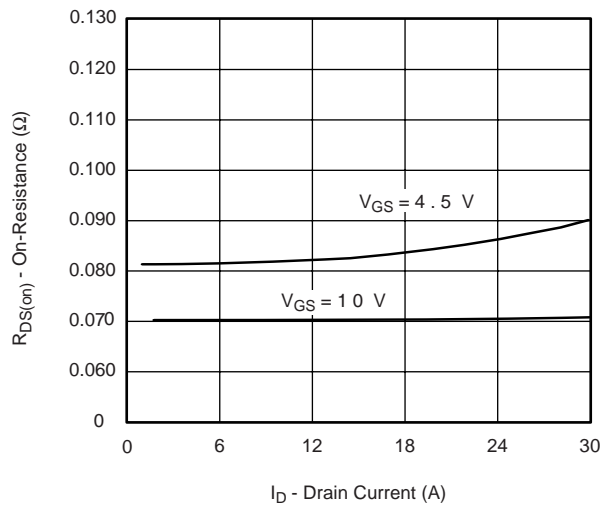

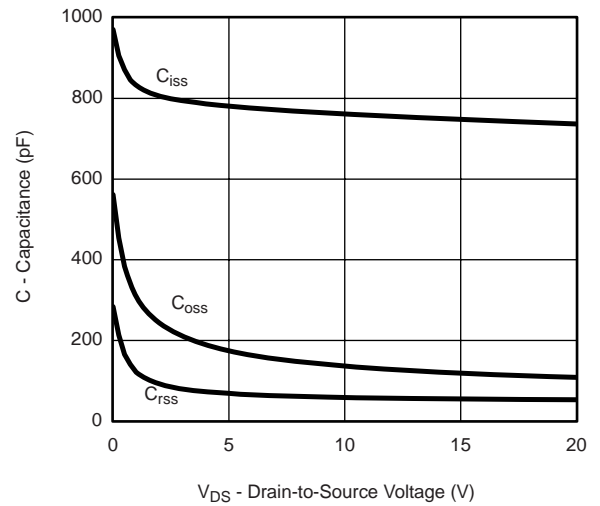

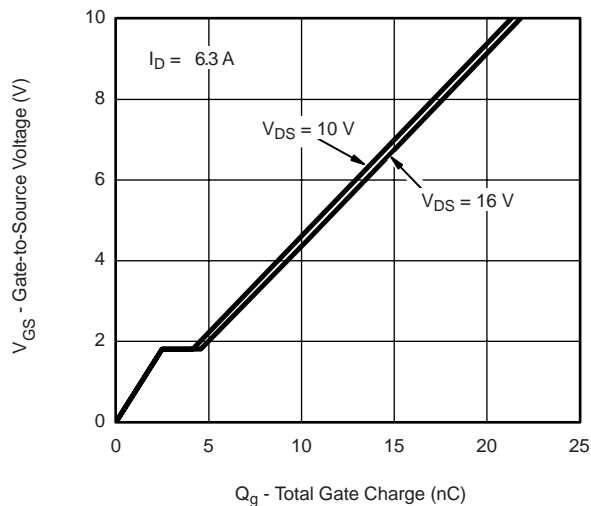
Transfer Characteristics



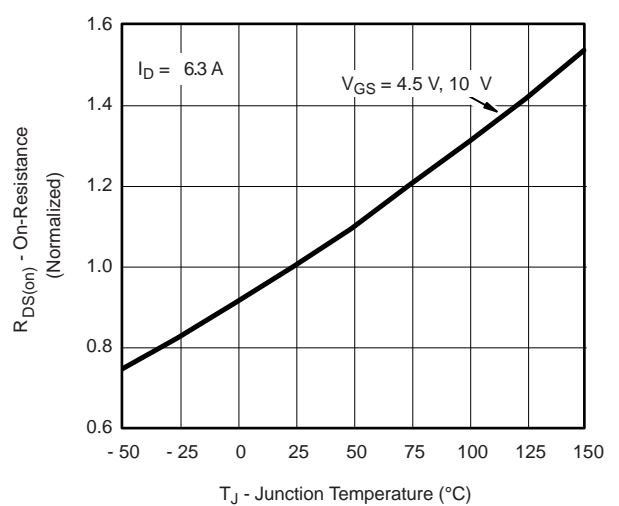
On-Resistance vs. Drain Current

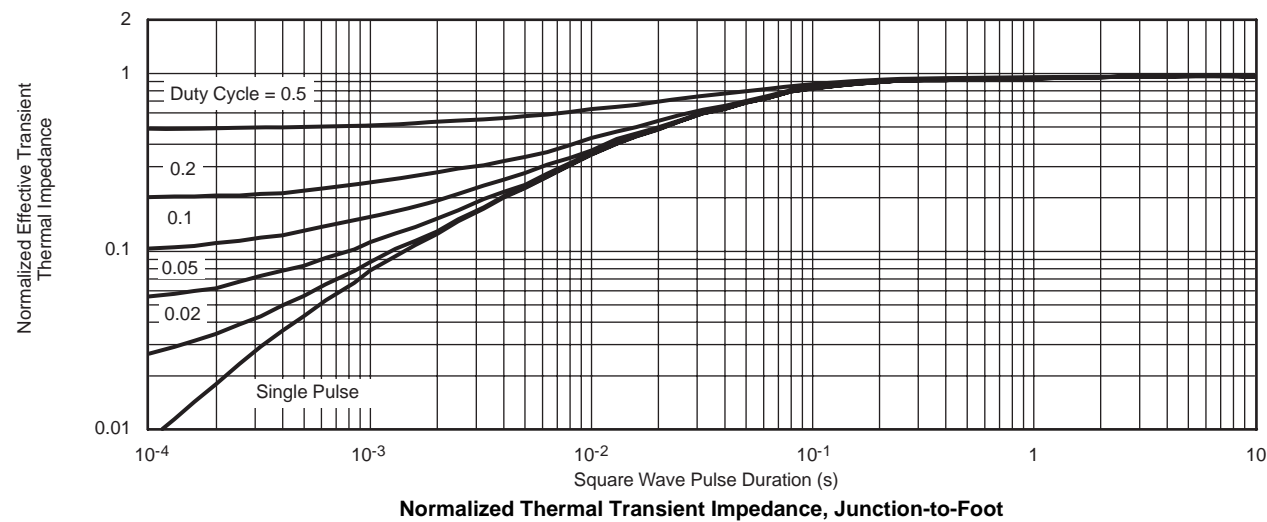
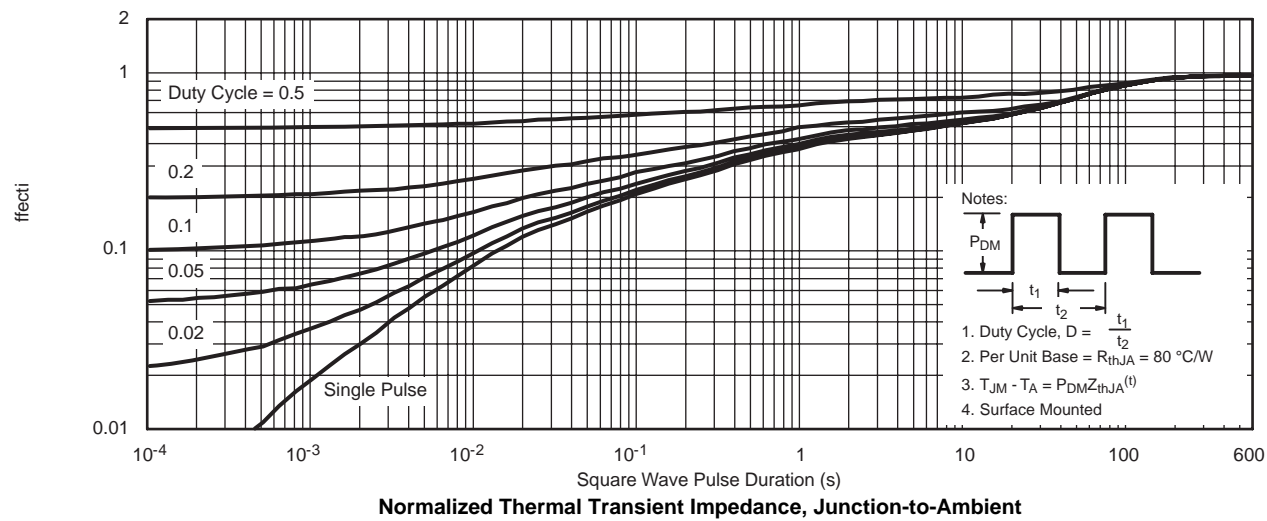
