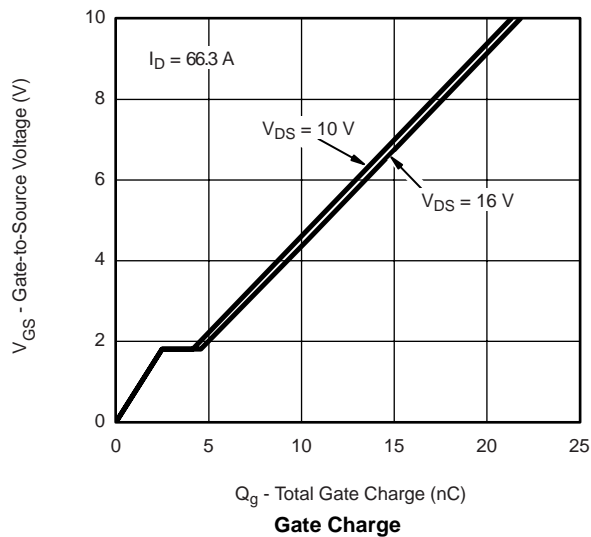

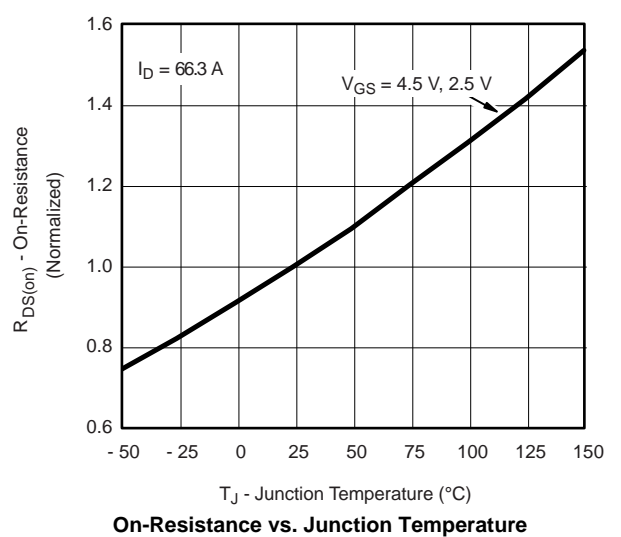
**On-Resistance vs. Drain Current**

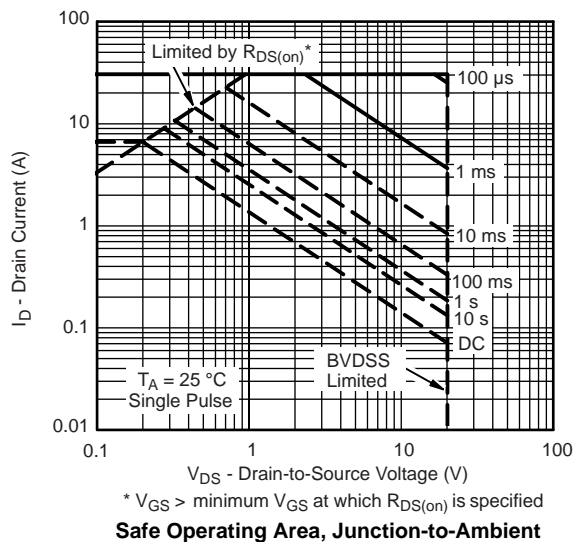
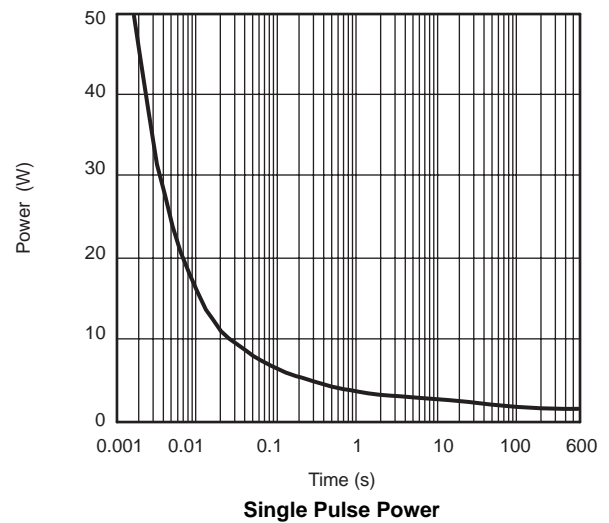


**Gate Charge**

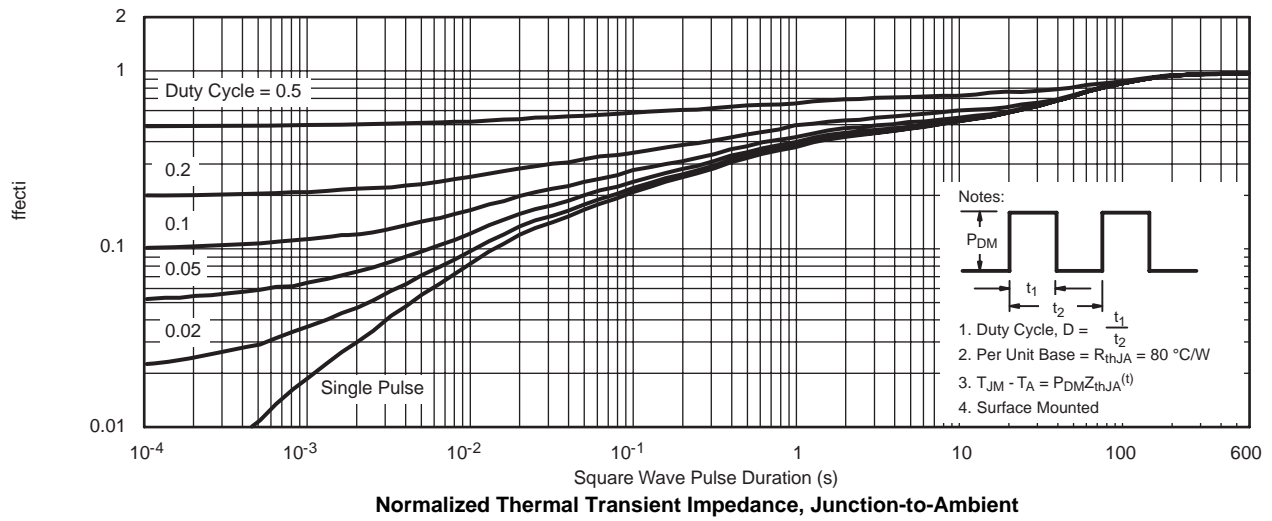

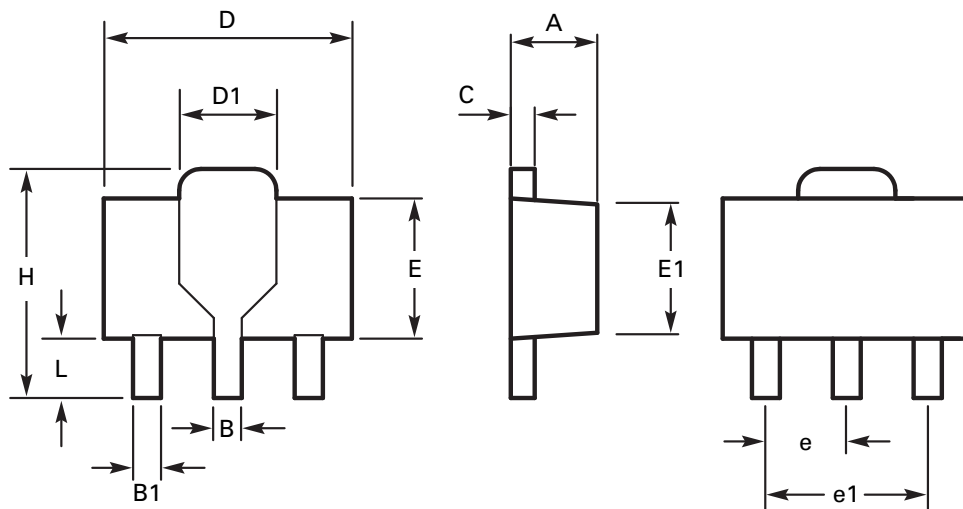
