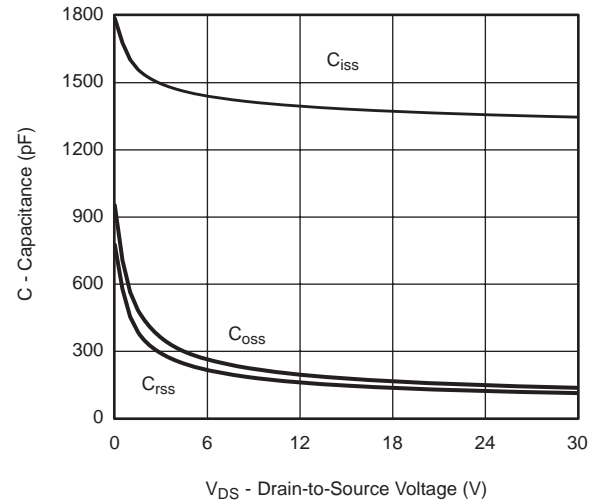

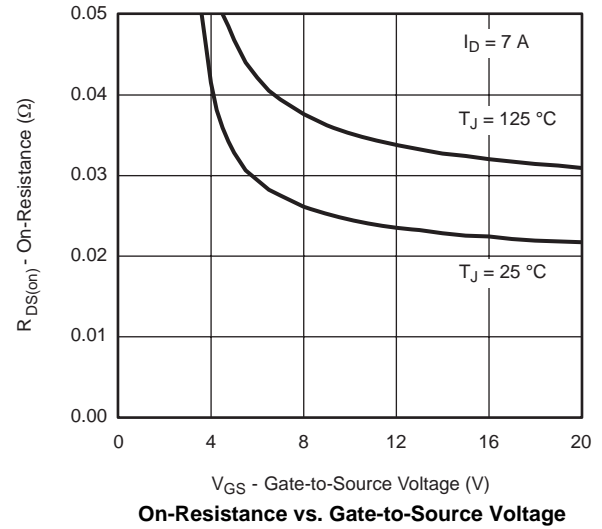
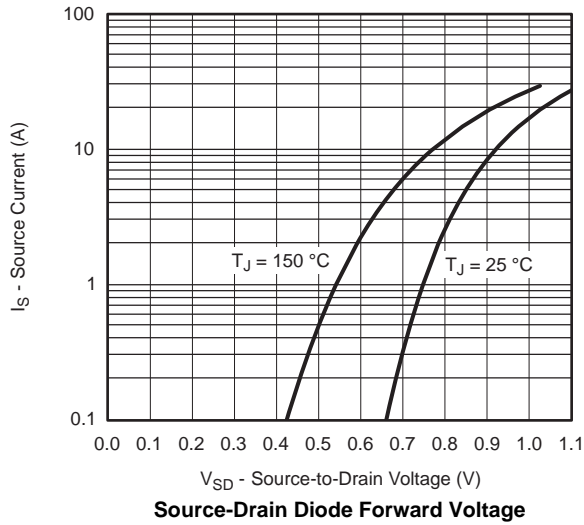


**Gate Charge**

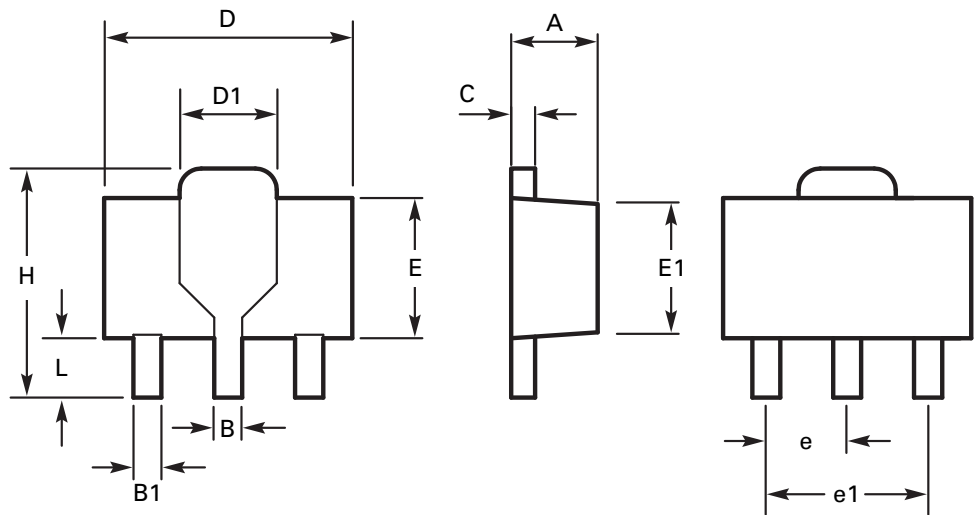
