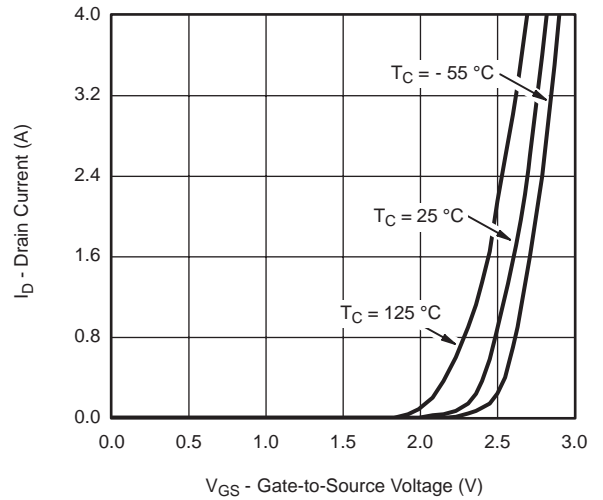

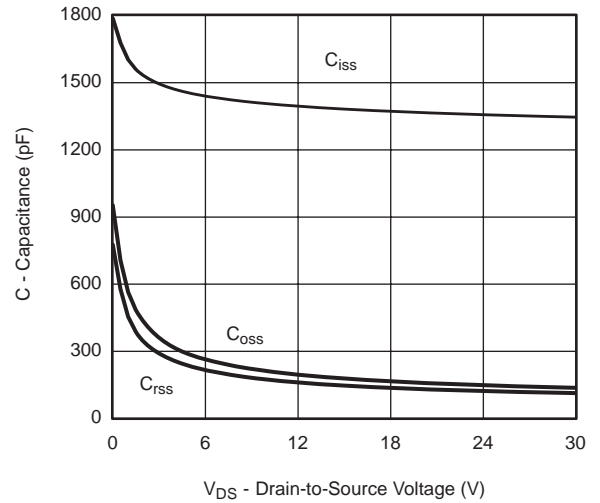

Capacitance

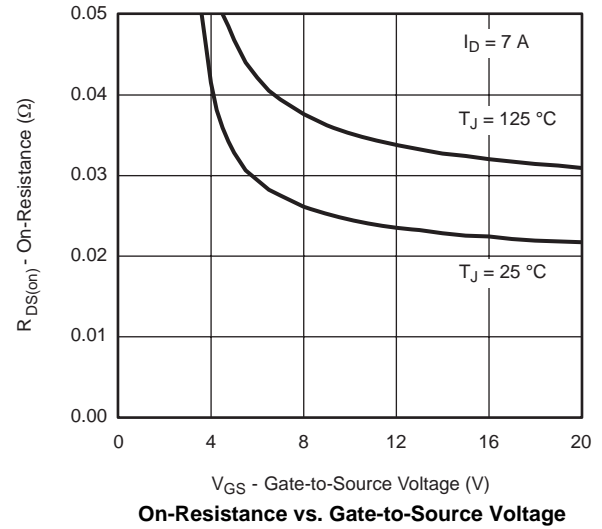
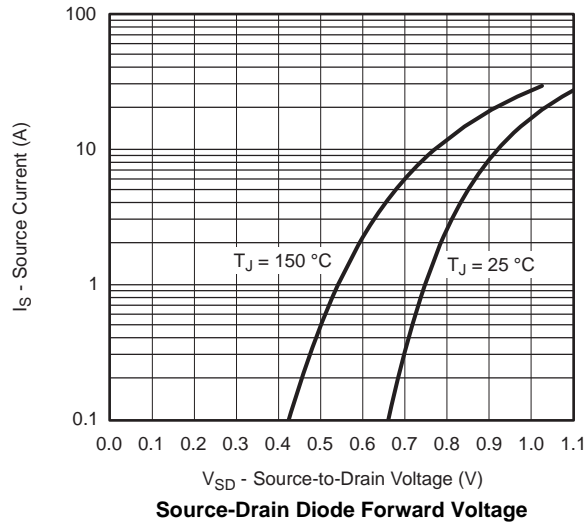


Gate Charge
