









Is - Source Current (A)

On-Resistance vs. Junction Temperature









Drain Source Breakdown vs.
Junction Temperature



Maximum Avalanche and Drain Current vs. Case Temperature






Normalized Thermal Transient Impedance, Junction-to-Case
