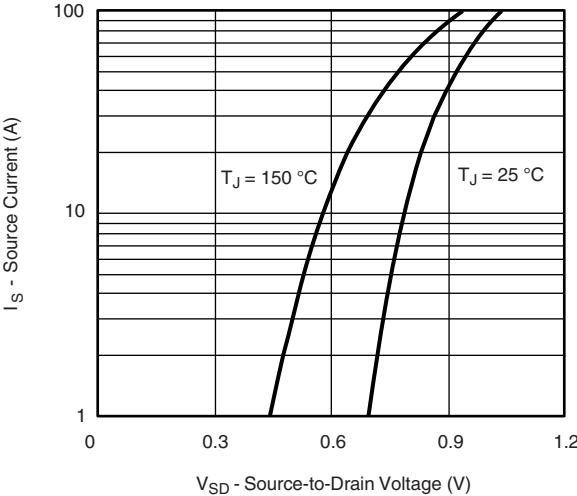

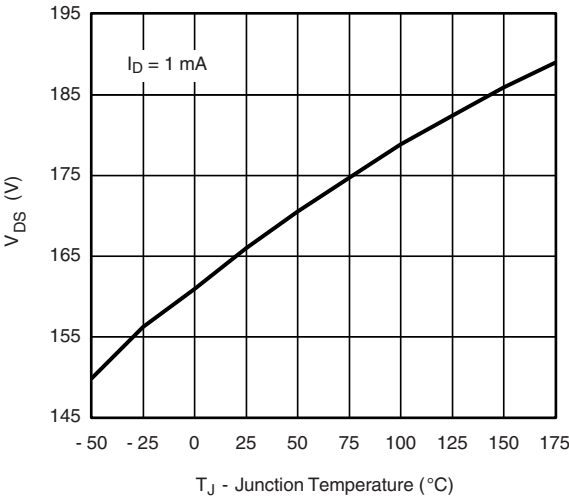

vs. Junction Temperature**

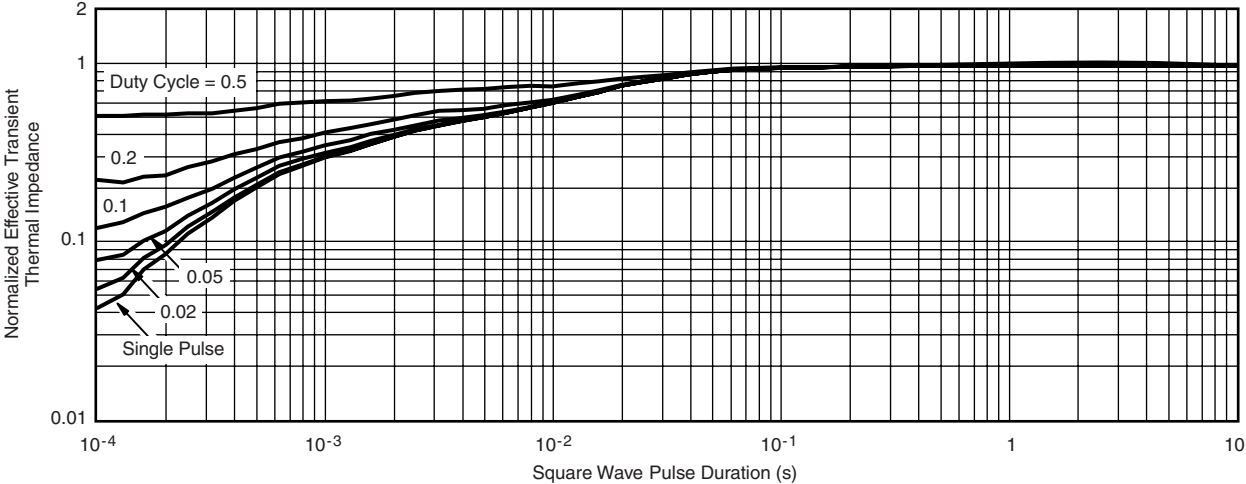
