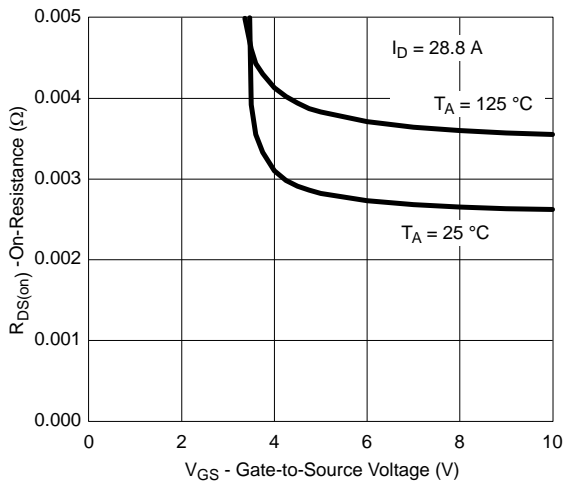

**Forward Diode Voltage vs. Temperature**



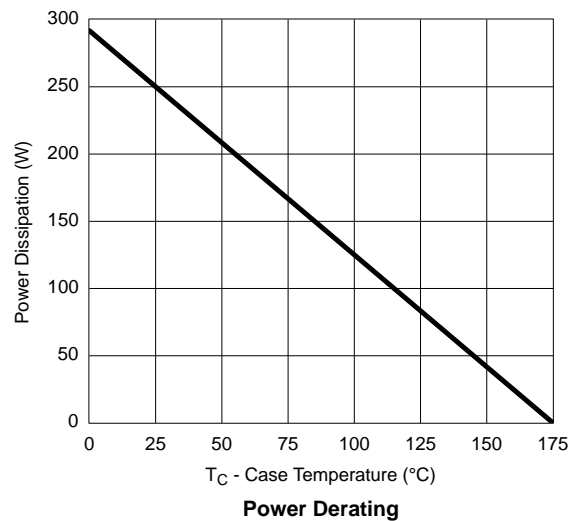
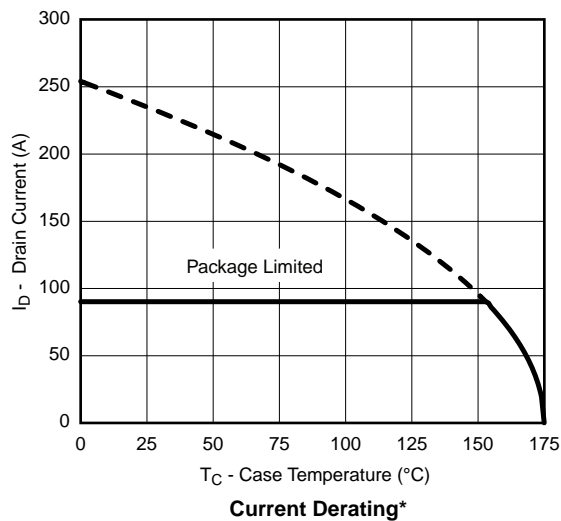

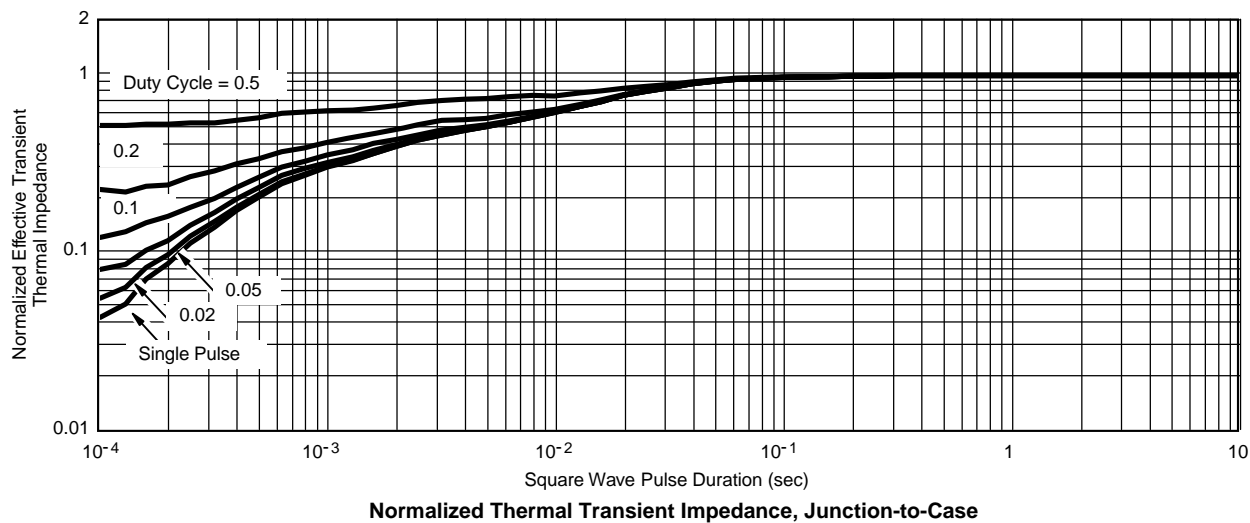
