







### **TYPICAL CHARACTERISTICS** ( $T_A = 25 \, ^{\circ}\text{C}$ , unless otherwise noted)



### **Gate Charge**




### **Source Drain Diode Forward Voltage**



### On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage




**Drain Source Breakdown vs. Junction Temperature**


Normalized Thermal Transient Impedance, Junction-to-Case


