









Source-Drain Diode Forward Voltage




**Threshold Voltage**

Single Pulse Power, Junction-to-Ambient









# MOSFET TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



 $T_{\mbox{\scriptsize C}}$  - Case Temperature (°C)









# TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Ambient
