
Source-Drain Diode Forward Voltage



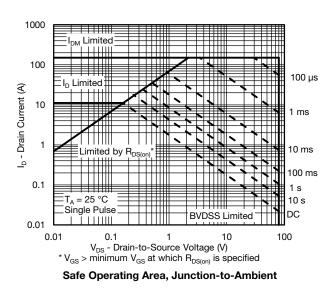
Threshold Voltage



**On-Resistance vs. Gate-to-Source Voltage** 




Single Pulse Power, Junction-to-Ambient










Normalized Thermal Transient Impedance, Junction-to-Ambient
