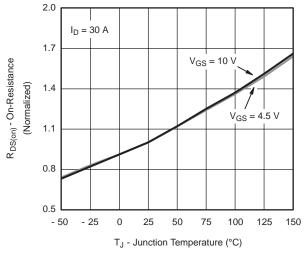

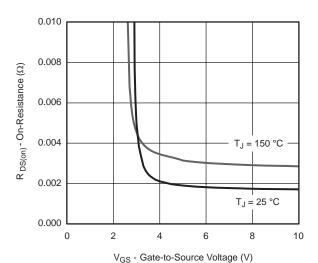






#### On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage

Threshold Voltage






Safe Operating Area, Junction-to-Ambient




