




Source-Drain Diode Forward Voltage




**Threshold Voltage**

Single Pulse Power, Junction-to-Ambient










## MOSFET TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Power Derating, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Ambient
