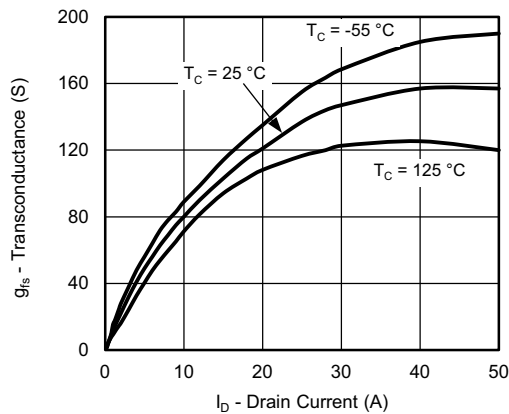

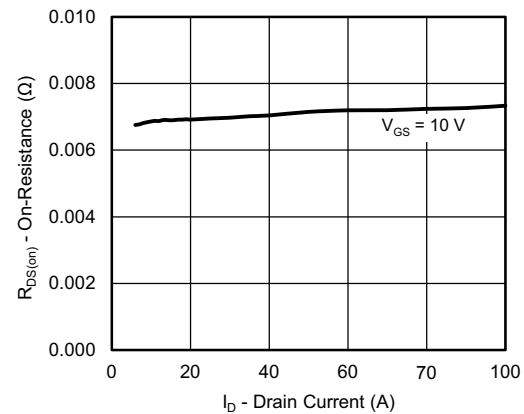

On-Resistance vs. Drain Current

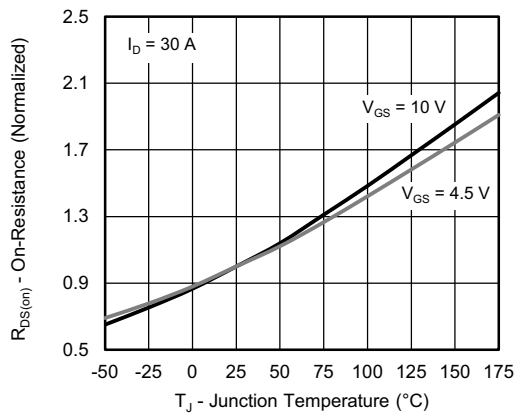

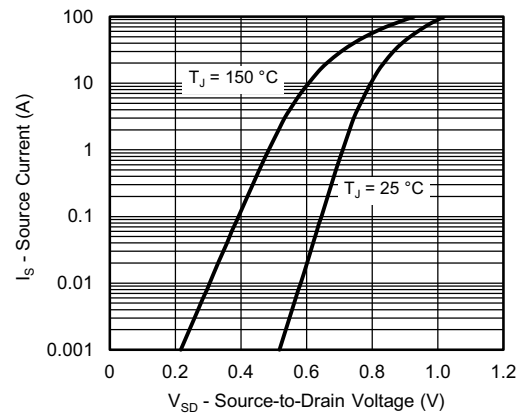

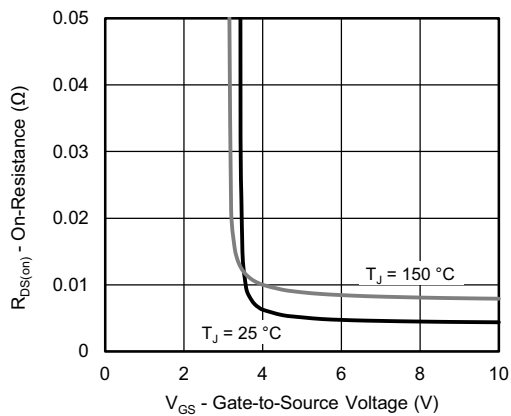

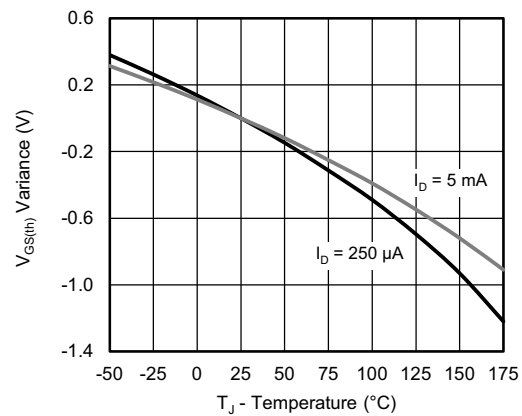
On-Resistance vs. Junction Temperature

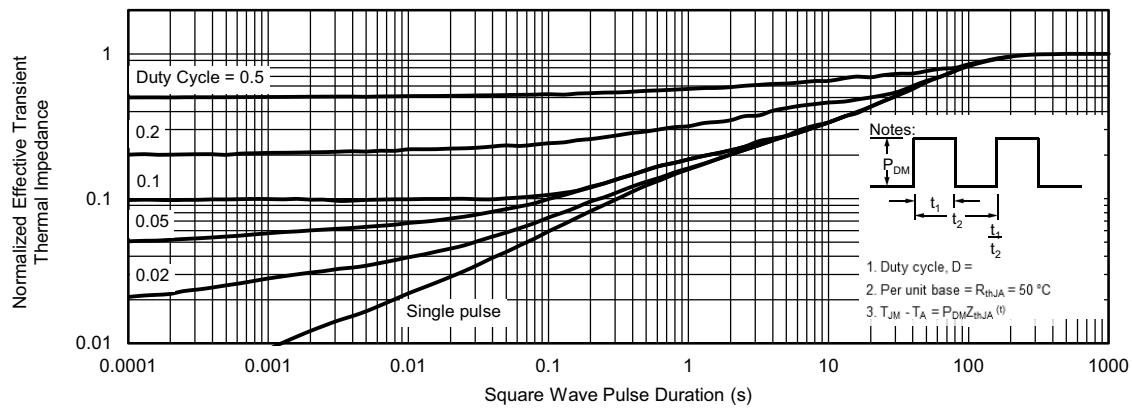


Drain Source Breakdown vs. Junction Temperature
