









## **Gate Charge**




## **Source Drain Diode Forward Voltage**




**Threshold Voltage** 



## On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage




**Drain Source Breakdown vs. Junction Temperature**


Safe Operating Area


