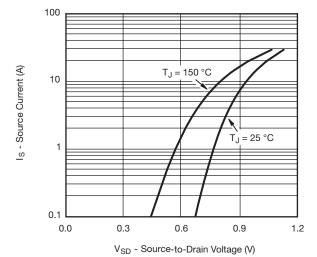

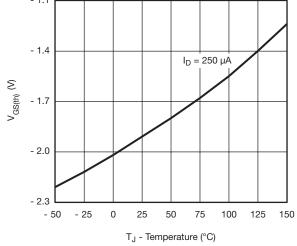




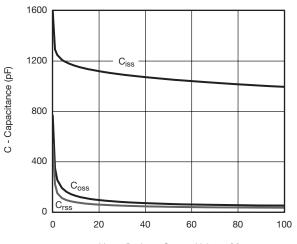

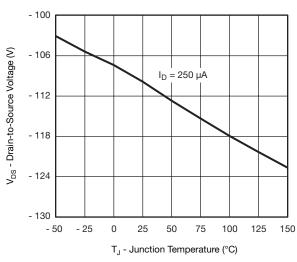
Source-Drain Diode Forward Voltage



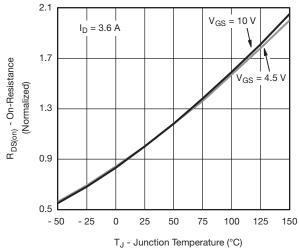
Threshold Voltage



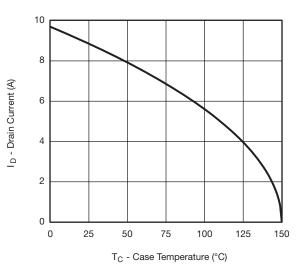
 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:capacitance}$



Drain Source Breakdown vs. Junction Temperature



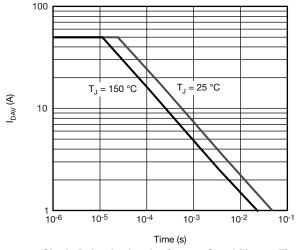
On-Resistance vs. Junction Temperature

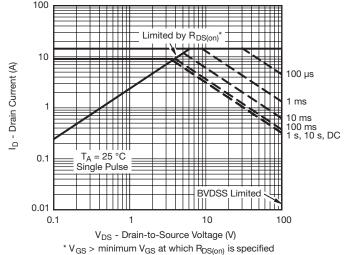

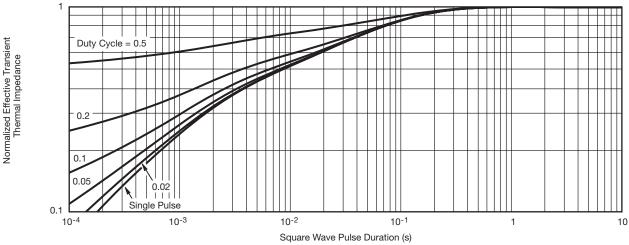




Single Pulse Avalanche Current Capability vs. Time

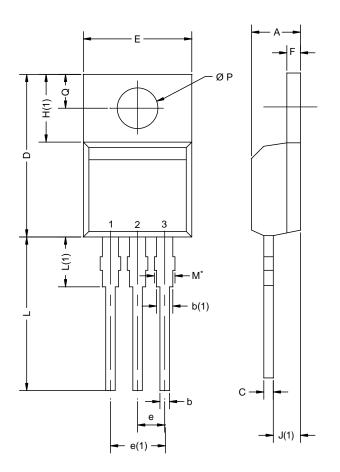
Normalized Thermal Transient Impedance, Junction-to-Case
