



Avalanche Current vs. Time



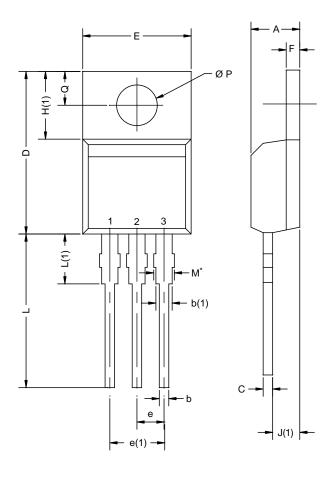
