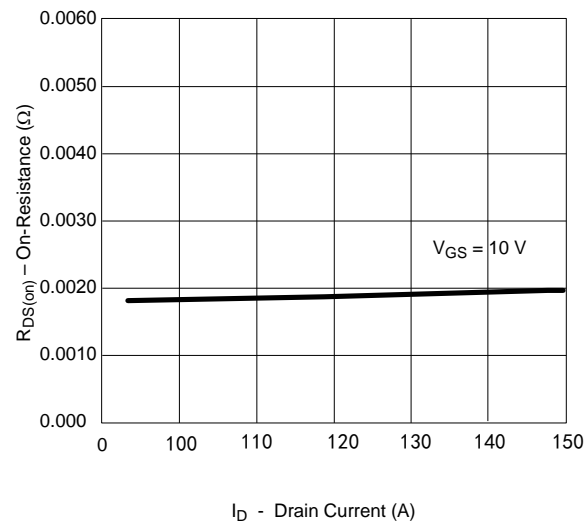

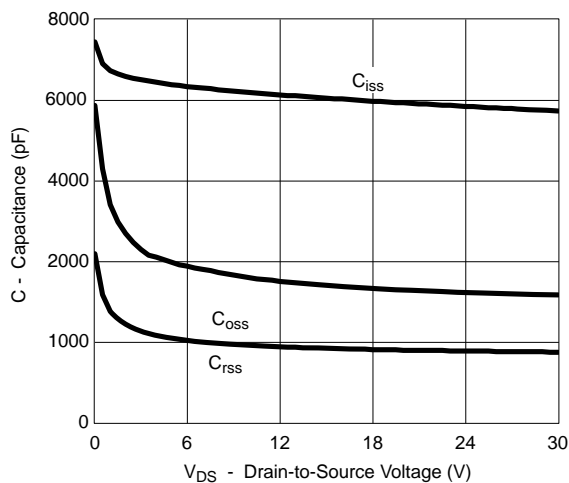

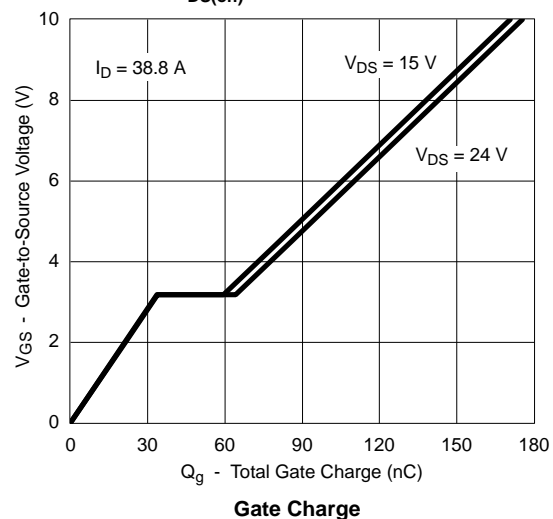

**$R_{DS(on)}$  vs. Drain Current**

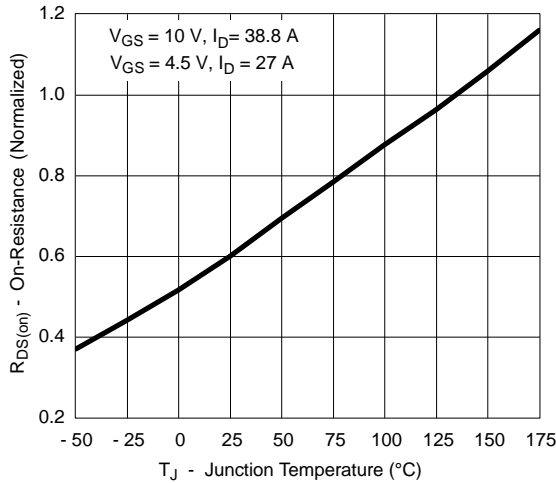

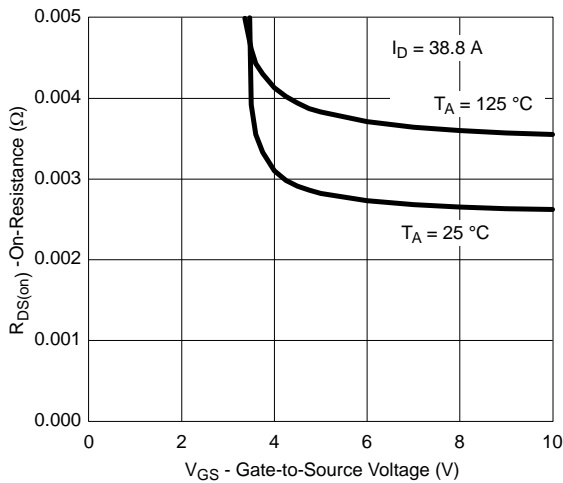

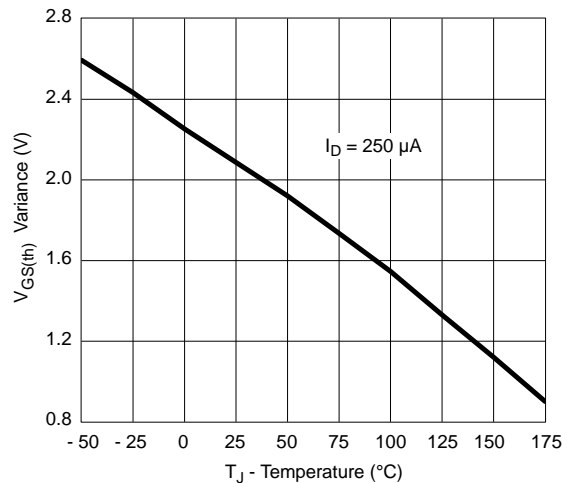
On-Resistance vs. Junction Temperature



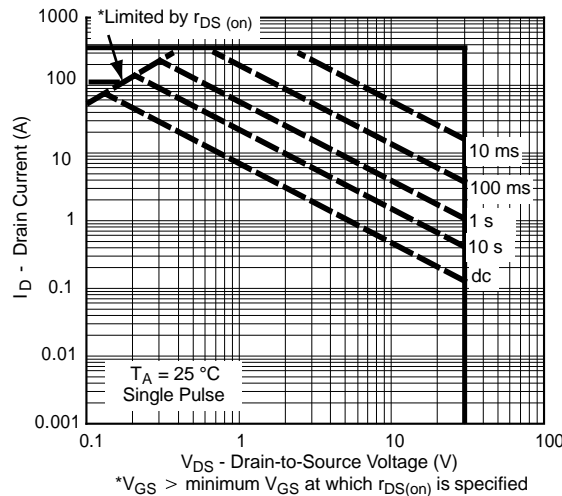
Forward Diode Voltage vs. Temperature



$R_{DS(on)}$  vs.  $V_{GS}$  vs. Temperature

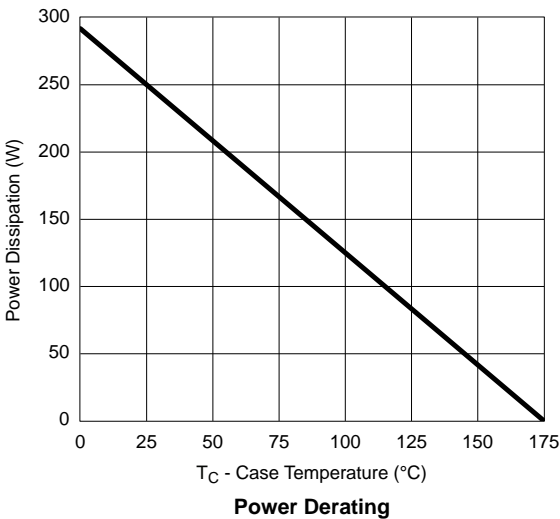
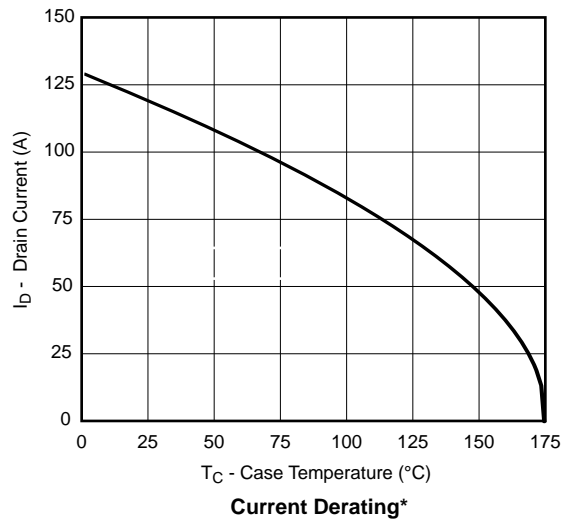


Threshold Voltage

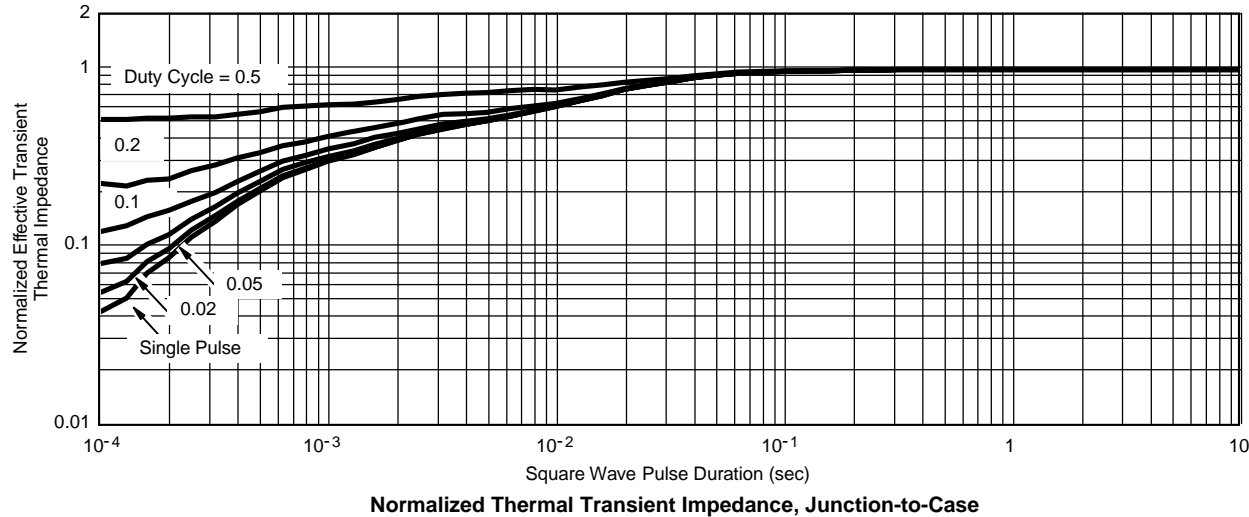


Safe Operating Area, Junction-to-Ambient

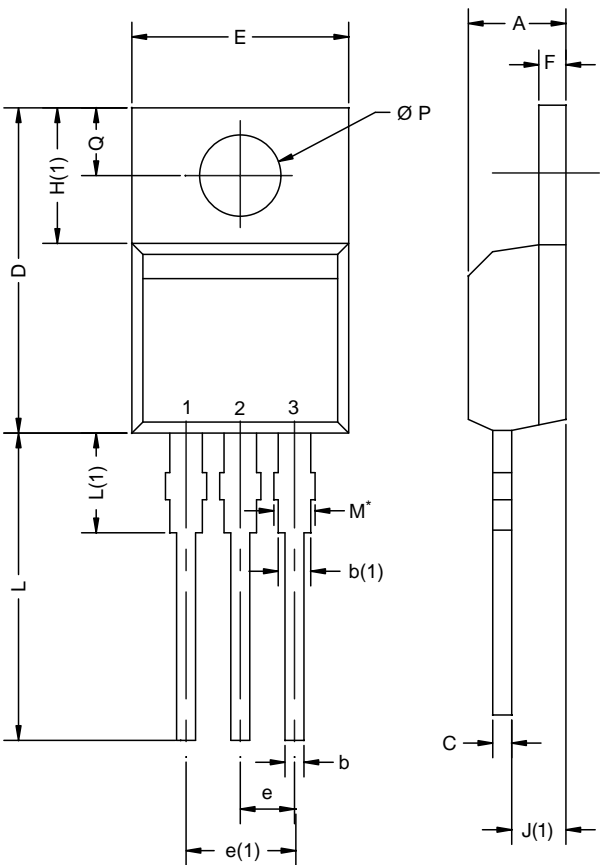
