


 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:Capacitance}$






On-Resistance vs. Junction Temperature




Source-Drain Diode Forward Voltage





Safe Operating Area




Normalized Thermal Transient Impedance, Junction-to-Case
