






On-Resistance vs. Junction Temperature


Source-Drain Diode Forward Voltage




T_J - Drain-Source Breakdown vs. Junction-Temperature



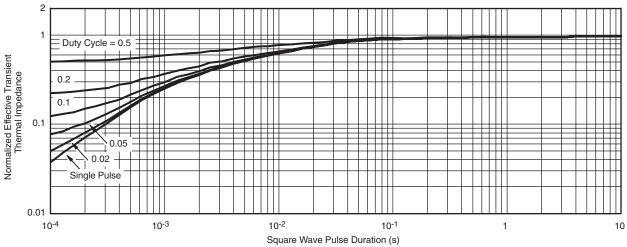

Maximum Avalanche and Drain Current vs. Case Temperature







Normalized Thermal Transient Impedance, Junction-to-Case
