


TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted









On-Resistance vs. Junction Temperature



Avalanche Current vs. Time




Source-Drain Diode Forward Voltage




Drain Source Breakdown vs. Junction Temperature





Maximum Avalanche and Drain Current vs. Case Temperature




Safe Operating Area
