









On-Resistance vs. Junction Temperature

Source-Drain Diode Forward Voltage



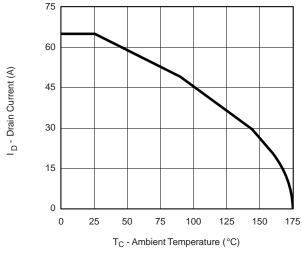
**Drain Source Breakdown** vs. Junction Temperature



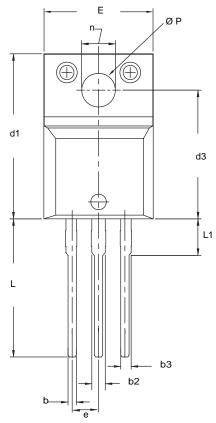


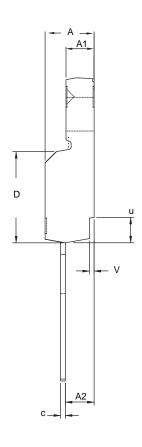


Normalized Thermal Transient Impedance, Junction-to-Case
