



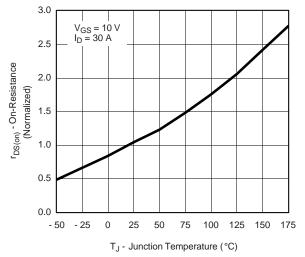
#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted





On-Resistance vs. Junction Temperature






Drain Source Breakdown vs. Junction Temperature



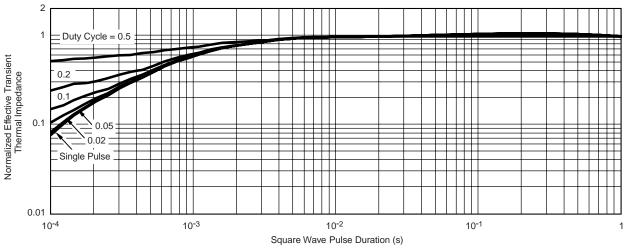

Safe Operating Area





Normalized Thermal Transient Impedance, Junction-to-Case
