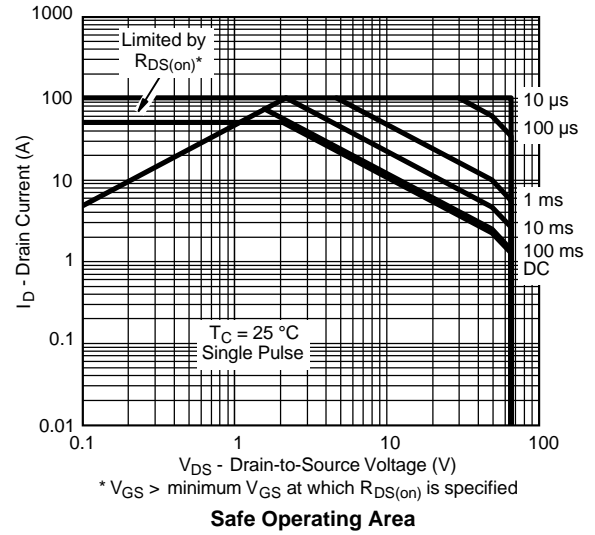

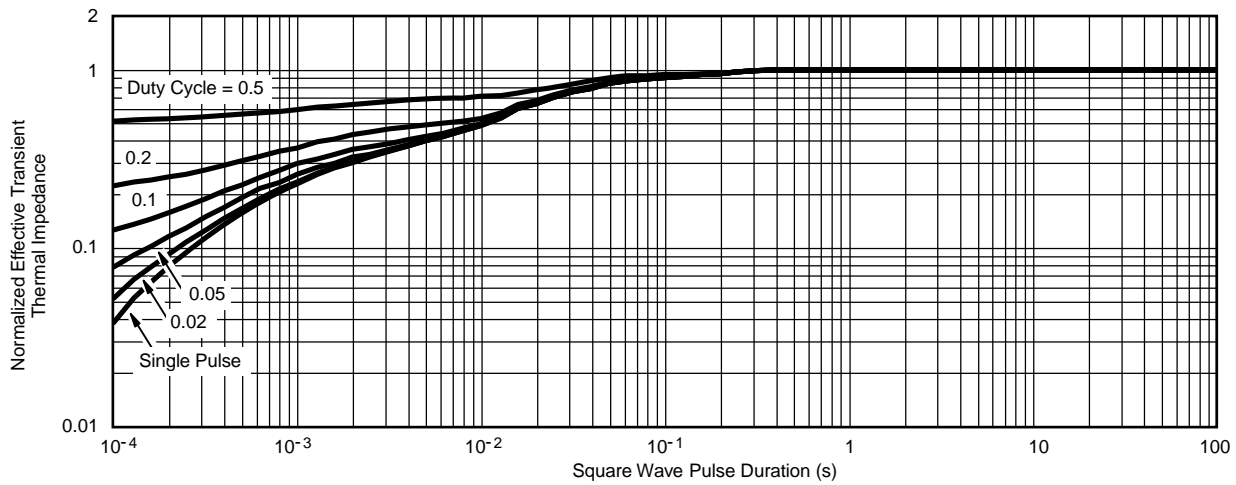

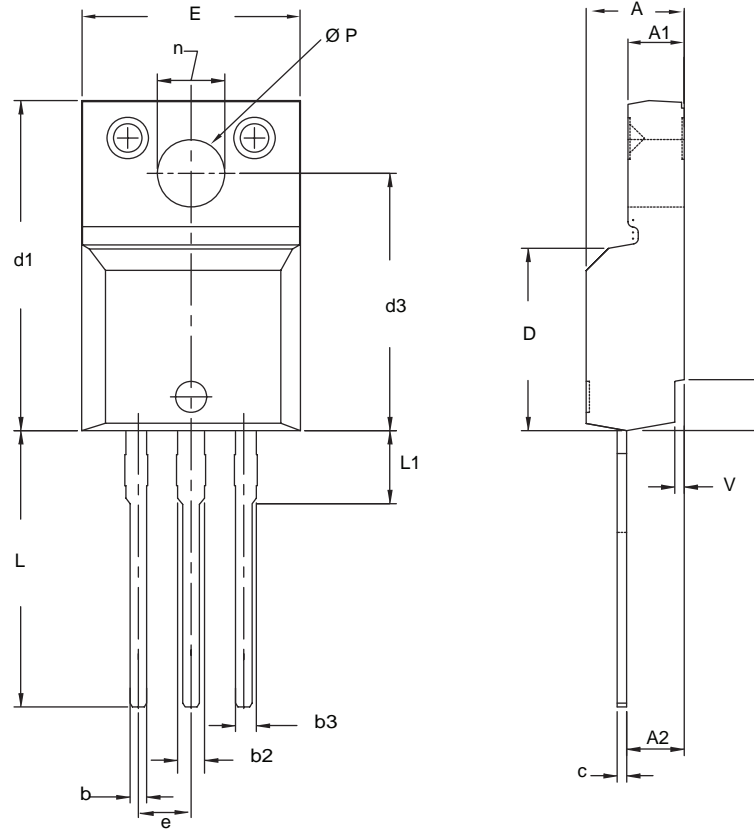
Maximum Drain Current vs. Ambient Temperature
