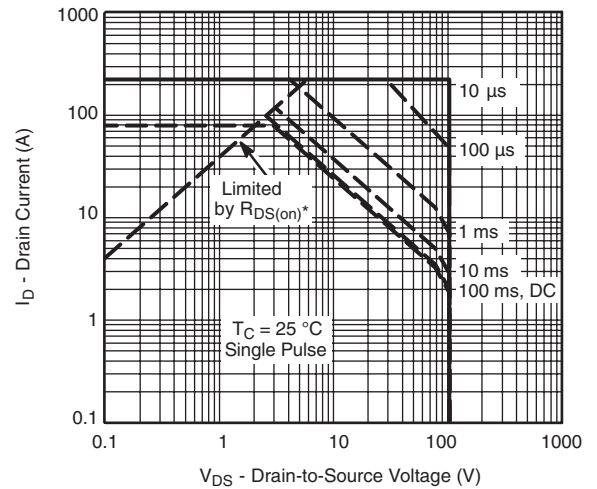

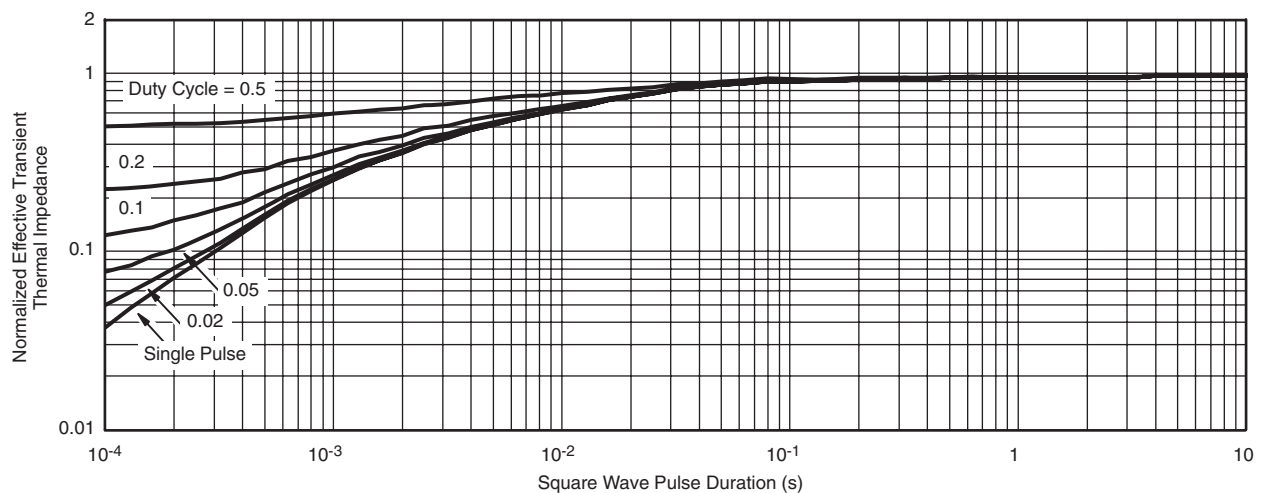

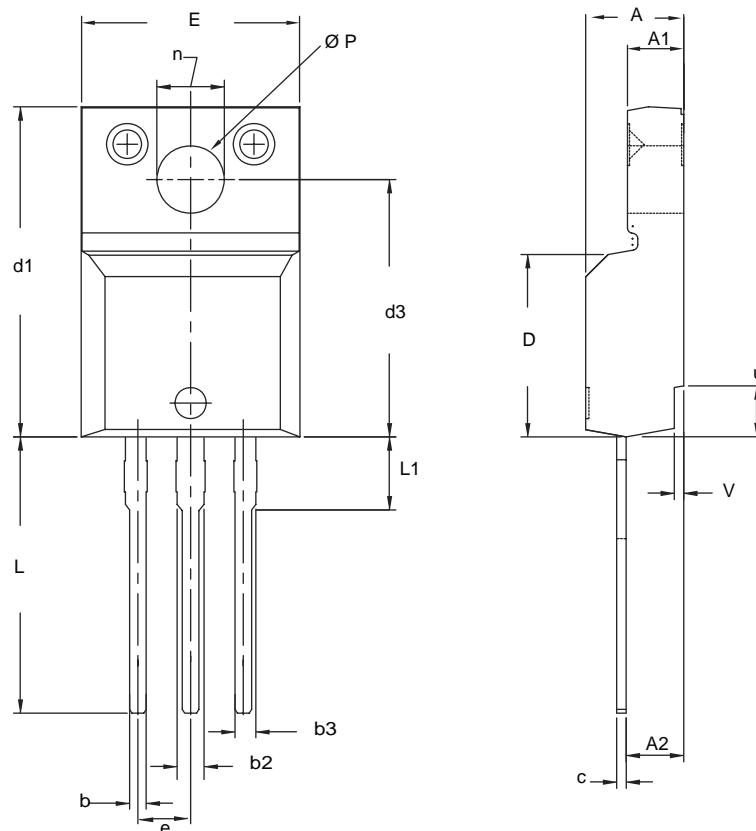
**Maximum Avalanche and Drain Current
