





### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)







Qg - Total Gate Charge (nC)












**On-Resistance vs. Junction Temperature** 





Source-Drain Diode Forward Voltage




Drain Source Breakdown vs. Junction Temperature


