

On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature




Threshold Voltage




On-Resistance vs. Gate-to-Source Voltage



**Drain Source Breakdown vs. Junction Temperature** 










 $I_{\text{DAV}}$  vs. Time


