

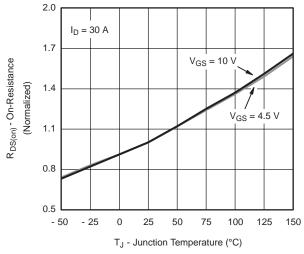








Threshold Voltage




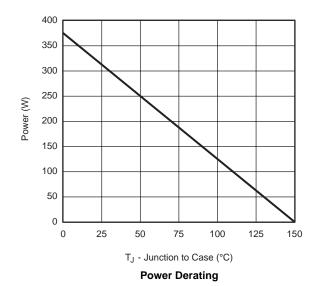

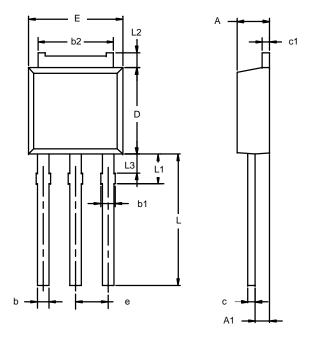
